


NATIONALISM - is a giant and invincible force which began to emerge strongly in the 19th century.

Yurij Chumatskyj is a nom de plume of a veteran of the Ukrainian Insurgent Army who participated in many of the events in Western Ukraine in the Ukrainian Carpathians for the whole of the period 1943-1948. In 1948 together with a fighting unit he crossed to the American Zone of occupation in Western Germany.

This book is a compilation of reminiscences, deliberations and experiences that guided many of his contemporaries. There are also a number of translations of articles written by a series of authors – Ukrainian, Polish, Jewish. They touch on one unresolved aspect of the historiography and perceptions of the Eastern European battleground, Ukrainian-Jewish relations and, in particular, deal with the predisposition of many people to adopt a simplistic, predetermined stance.

No apology need be given for the forthright treatment of a complex, but not well understood, subject.

#### INTRODUCTION

#### THE FIRST TO FIGHT HITLER'S EMPIRE

Decades after World War II both the Western press and the propaganda offices of the Russian empire are blackening the name of the Ukrainian nation with the tag "Nazi collaborators" and "war criminals".

On the other hand it is an historical fact that Ukraine was the first nation to oppose the German empire with arms.

The Germans took Austria and Czechoslovakia without firing a shot. The territory of Zakarpatska Ukraina had been occupied by Czechoslovakia after WWI and was still under their control. This territory Hitler now gave to his allies, Hungary. Ukrainians strongly opposed this turn of events - they proclaimed an independent republic and organised an army. The ranks of this army soon swelled with patriotic Ukrainians from various parts of Ukraine who in their thousands illegally crossed the border to join up.

In March 1939 this army faced the armed forces of Germany's empire in a heroic battle which saw the loss of hundreds of lives. One of the organisers of this army was Roman Shukhevych-Chuprynka, who later became the Commander-ih-Chief of the Ukrainian Insurgent Army which fought both the German and Russian occupiers of Ukraine at least up to 1950.

During this same period Russian and Western diplomats were queuing in Berlin to sign a whole string of political and trade agreements with Hitler.

#### ON THE PATH TO A NEW HOLOCAUST?

The people of the world live in groups distinguished by their differing cultures, religions, languages, races, etc. These nationalities and tribes also differ in size and history of development. Thousands of years ago some of these groups developed efficient systems of government which led to great achievements of culture and history. Such civilisations were Persia, Egypt, Greece, China, Kyivan-Rus (Ukraine), Rome, the Anglo-Saxons. Such national development was sometimes short-lived or curtailed because of wars of aggression or invasion by other countries. There are nations still today fighting for independence from foreign masters.

The successful takeover of Eastern Europe by 20th century Russian imperialists was made possible by the acquiescence of England, America and a prominent segment of world Jewry. After the war Britain realised her mistake. In the words of Winston Churchill, "We killed but one swine and not the other too". Half of that great cultural storehouse that is Europe was now controlled by Russia. Some Jewish elements, particularly active pro-Soviet Zionists, remained willing servants of Moscow's empire-building apparatus.

These servitors of Moscow cunningly coaxed thousands of dollars from western countries which was then used in further subjugation of and propaganda against the captive nations. Some Jewish media interests kept up this action in the press, radio and television, even though Moscow was collaborating with the Arabs for the destruction of Israel.

Many migrant groups, for one reason or another, live in countries other than their own homelands. Some of these groups form large numbers, like the Italians, Greeks or Germans. Other migrant groups are small.

All of them are loyal and dedicated to their new homelands while at the same time keeping a link with the old. In cases where the mother country is now behind the Iron Curtain or subjugated by a foreign power, the refugees who find themselves in a new country feel a special responsibility towards their country of origin. All of these migrant groups exist peacefully and little fuss is made of them in the media.

Great media fanfare and a high profile is given, however, to the relatively small Jewish group. In the past their influence has led various countries into troublesome situations. Lately their manipulations are leading America into a potentially catastrophic situation vis-a-vis the Arabs. A section of world Jewish leadership seems intent on forcing its will on many world governments.

To understand the reasons and consequences of Jewish action one needs to take a quick look at Jewish history.

#### JEWISH HISTORY IN THE DIASPORA

For centuries the Jews were a stateless people. Had they been a state-conscious group they would have taken one of the many opportunities during their wanderings to take control of what at that time were vast tracts of uninhabited land in such places as North and South America, Australia and other continents. During these journeys, from the time of Babylon-Egypt to the 20th century, they assimilated a great deal from many different cultures. This differentiates the European Jews from the Jews of Palestine. An unfortunate byproduct of their wanderings was the anti-Jewish feeling that developed in each country in reaction to Jewish obstinacy and arrogance. Some of these coun-

tries reacted with pogroms and complete expulsion of the Jews. When Hitler planned to drive them out of Germany the Western nations refused to accept them. In fleeing Germany they went to Poland, Western Ukraine, Rumania and Czechoslovakia.

#### ISRAEL IS BORN

After the war and the Jewish holocaust it was the patriotic Jewish youth who decided on a heroic stand and won Jewish statehood. This was the beginning of a new era. The potential for Jewish development now that they had their own country was enormous. seemed that pogroms would now be a thing of the past, that Jewish influence in other countries would cease, and that the building of the Jewish state would realise all their long-held hopes. The sympathy and the good wishes of the whole world were now with them, and they had the advantage of large compensation payments from Germany. After having undergone such recent tragic suffering it was expected that Jews would sympathetically deal with the Jewish and Arab populations of Palestine and Israel. Such peaceful co-existence was not to be.

It turned out that advising, influencing or controlling foreign nations was one thing, successfully running one's own country was another. Israel has over 30 political parties, the workers are not productive, inflation is running at several hundred percent. Hatred of their Arab neighbours grows daily. The country devours the billion-dollar subsidies it gets from the Goy countries. The agricultural system is based on Muscovite principles - the collective kibbutz - which has proved to be a failure in Eastern Europe.

The kibbutzim were built by idealistic Jewish patriots under harsh and often dangerous conditions. Today

these kibbutzim can only exist thanks to a steady diet of American dollars. I had the opportunity to spend several days at a kibbutz. In the evening the guests, mainly from America, were treated to films in the These films showed the construction of the kibbutz and the extreme hardships of the early days. Following this we were shown how "this Jew from New York" bought them some buses, some "Jew from Los Angeles" financed the building of the hospital, others contributed to buying ammunition so that they could defend the kibbutz, and so on. This subtle appeal resulted in many of the visitors, tears in their eyes, pledging contributions to the kibbutz. When I asked one of the young workers if the kibbutz could run without outside financial help he said, "only for three months". In answer to my question as to what he had planned for the future he said that he was trying to get to America.

Looking closely at the politics of the Jewish state it would seem to be an extremely senseless one. In nearly 40 years of Jewish statehood they have made more enemies, it would seem, than in the last three thousand years. Their only ally now is the United States of America which devotes much of its great economic prosperity and large military force to helping Israel. One would expect the Jews to be grateful for this, yet how many Jewish spies for Russia were there in America? Who gave Russia some of America's most sensitive secrets, including the atom bomb?

What fate awaits the American and Jewish people when, after having involved the United States so deeply in her troubles, Israel finds America unwilling to feed her or shed blood on her behalf?

What will be the mood in the world courts should Jews be put\_on trial for mass killings of Arabs? The Jewish people choose to ignore these problems, strongly reacting to any criticism with the words "anti-Semitic!". Have they ever thought to ask them-selves why the whole world is supposedly anti-Semitic?

#### NAZI CATCHERS OR RUSSIAN STOOGES?

Over forty years after World War II, instead of the world media taking a hard look at the continuing disregard of national and human rights by Moscow, the Western press devotes much space to Nazism which was defeated and crushed at the war's end. Today that empire controlled by Moscow is committing horrific wrongs in Estonia, Latvia, Lithuania, Ukraine, Hungary, Poland, Czechoslovakia, Yugoslavia, Afghanistan and other countries.

More than forty years after the end of World War II and the death of Hitler the west is seeing a new campaign against "Nazi war criminals" - a campaign which is becoming increasingly intense.

To the uninformed this action seems quite normal and proper. In line with the laws of the West any person guilty of a crime must be subjected to lawful prosecution even though the criminal might be the president himself.

Unfortunately this campaign of catching "Nazi war criminals" is a most dangerous Trojan Horse for the Western world – a Trojan Horse prepared in Moscow by a large propaganda apparatus.

So that we may better understand this exercise let's take a look at the relevant historical period which gave rise to this worldwide campaign.

Hitler persistently organised Germany for war and world conquest. Similar plans were prepared in Moscow

but much less successfully. Previously a degenerate Russian aristocracy and their Tsar had brought the empire to the brink of collapse. Japan destroyed the Russian navy and the fortunes of World War I meant the imminent downfall of the Russian empire. Unfortunately world socialism, financed to a large degree by pro-Soviet Jews, rebuilt the empire in the garb of Marxism with its appealing vision of a communist paradise.

The new "red tsars", under the guise of communism, once again hastened to conquer their neighbouring countries - countries which had taken advantage of the revolution and proclaimed their independence. Even after they had again been invaded by Russia, countries like Siberia, Georgia, Azerbaijan and Ukraine continued to show strong opposition to occupation.

The task of bringing to heel the subjugated nations was begun in earnest with a reign of terror unparalleled in history. The plan included the liquidation of whole nations. To mask its sheer aggression and imperial conquests, Russia created the term Soviet Union. In creating this fictitious entity Russia firmed control over her empire by binding all the subjugated nations into a new russified mass at the expense of their culture, language and history. Behind this smokescreen Moscow rules an empire in which the captive nations have as much say in Moscow as the Judenrat had in Hitler's New Europe. Even worse than under Hitler, the possession of nationalistic books could mean execution or 25 years in the Gulag.

When the resistance in Ukraine seemed interminable, the politburo decided to organise a man-made famine in which over 7 million people died of hunger in the richest grainlands of Europe. Later Khrushchev himself confessed that Moscow planned to liquidate the whole nation.

The Soviet "advice-seeking council" state was facing complete ruin and bankruptcy in 1939. There were mass defections of Soviet soldiers to the Germans in the first days of the war. The small heroic state of Finland dealt the Soviets a mighty body-blow. The empire's fortunes changed when Russia made a pact with Hitler's Germany and they started World War II by attacking Poland.

It was America who saved the empire this time. On advice from Moscow's apologists the United States supplied food, funds and arms to Russia. Once again Russia had the capability and renewed confidence to pursue her imperialist aims. The communist socialist message was promoted heavily in the West. The hammer and sickle were prominent. At the same time dictator Khrushchev, visiting the West, shouted "We will destroy you!".


The opportune moment had arrived to successfully promote international revolution and the subordination of the world to Moscow. Russia well knew that it had nothing to fear from the West.

### THE STATE OF THE EMPIRE

In the free world the fifth columnists, Moscow's "useful idiots", and to a large extent world socialism fiercely support the Russian communist empire. The enemies of the Russian empire were the captive nations. Estonia, Latvia and Lithuania made a superhuman stand against the aggressor which cost them thousands of people executed or sent to prison camps. The proud Caucasian nationals battled the enemy over a period of years.

## Ukrainian Resistance in World War II

The greatest resistance to the occupation was made by the Ukrainian Insurgent Army. In their formations of platoons, companies and battalions they were helped by a network of thousands of armed nationalist members, and actively supported by the bulk of the Ukrainian people. The Ukrainian Insurgent Army battled from 1942 against the German empire and until 1952 against the Russian empire – even longer in some areas.

The arrogant and boastful Russians, after so fortuitously ending the war and tricking the West at Yalta
and Potsdam, now ferociously turned to the problem
of finishing off the Ukrainian nation, not caring what
base methods were used. During this action Russia
forcibly transported hundreds of thousands of people
to Siberia. From the western regions of Ukraine such
as Yaroslavschyna, Kholmschyna and Lemkyvschyna one
million Ukrainians were moved within days, in Ford
vehicles, to areas of western Poland.

Things weren't much better in Poland, a country which had been so shabbily betrayed by its allies. When Germany and Russia attacked Poland much of its army fell captive to the Russians who well knew the pride and dedication of the Poles. So as to eliminate a future threat from the ranks of the army officers Russia executed 12,000 Polish officers and an unknown number of regular soldiers at Katyn in 1940. During the Polish uprising against the Germans in Warsaw Russian soldiers were within 2 kilometres of the city, yet they only moved to help the patriotic Poles just when the Germans had virtually finished them off. The post-war Polish communist government, under orders from Moscow, carried out mass arrests of the Polish underground which had fought against Germany, and many of these were killed.

### RUSSIA'S DESIRE TO CRUSH RESISTANCE

The struggle against Russian imperialism continued for many long years after the end of World War II in countries such as Eastern Germany, Hungary, Czecho-slovakia and others. Russian divisions were on active manoeuvres for a number of months in Poland, and lately Moscow has managed to neutralise the 10-million strong Solidarity democratic union. Even in prison camps the Russians were being confronted - in 1954

during an uprising in a camp in Kingiri 500 Ukrainian women were mowed down by tanks.

To detail the terrors of the Russian empire would take hundreds of volumes. People in eastern Europe are well acquainted with Russian brutality and millions fled to western Europe during the war. Russia knew that these people would be her greatest and most dangerous enemy, since in the free world they would be able to tell the terrible truth of Russian domination. For this reason Russia used all her powers of persuasion to forcibly have these people repatriated to their Russian-controlled homelands. In this she was partially successful because of initial help from the West. Those who managed to remain in the West are watched over closely by Moscow and a number of individuals have even been captured or assassinated.

These people are the only defenders of the captive nations in the free world. For many years they have cautioned the apathetic West against the dangerous aims of the Russian empire. That is why Moscow hates them and is fearful of them. And what a cunning ploy it has perpetrated - "hunt down war criminals, they are all Nazis". Into this category of "war criminal" they count each and every patriot who stood in defence of his subjugated nation. To prove their allegations the fascists of Moscow, the KGB, will provide the West with mountains of documents. And who in the free world will believe the patriots of Latvia, Estonia, Lithuania, Czechoslovakia, Ukraine and other enslaved nations of the Russian empire, when they try to tell of the holocausts and suffering of their nations only to be "proven" by Moscow to be criminals and felons.

Meanwhile a great slave labour force has been mining coal and uranium for Russia's expansionist actions. This labour force also serves as a means of ridding

the empire of her nationalist enemies. The Russian patriot Solzhenitsyn, among others, documented these events. At long last the myth of the communist worker's paradise burst like a bubble. The state of

the empire became common knowledge - the extent of the poverty, the long queues for everyday items, the breakdown of agricultural production. Once again America and the West come to the rescue with attractive grain deals and financial assistance.

But the terror, the arrests, the oppression continue. Only in this way can Moscow hold on to her empire. Against fierce nationalism, against people who are willing to sacrifice their lives for an ideal, Moscow can only respond with terror. Hungarians, Czechs, Slovaks, Baltic peoples, Germans, Ukrainians and many others – these are the enemies of the Russian empire. Against this enemy Russia can only practise terror.

There is no-one who would give his life for the "ideals" of Russian communism. Moscow's allies can be found only in the free world. These lackeys, naive earnest followers, and, in the words of Lenin, "useful idiots", work unceasingly for Moscow's ends. They push Soviet propaganda in academic institutions and the media. They are vocal and powerful in the union movement. They steal or buy western technology. They slander the name of the subjugated nations and their migrant communities in the West.

Apart from this they have two important tasks. The first is to destroy the capitalist system in the west. The second is to defeat the independence movements of the colonial nations of the Russian empire.

The first task is well under way. It is possible to organise sabotage strikes which cost Western governments millions of dollars. Often enough there is a flotilla of ships waiting outside strike-bound ports while goods for export are indefinitely held up. The perpetrators of this action are loyal not to their country, but to the party - and ultimately to Moscow.

Another way of attacking the capitalist west is to orchestrate massive demonstrations against certain Western policies - nuclear energy, Chile, South Africa, aboriginal rights. Once again this tactic has proved successful, for while these anti-west demonstrations are large and well-organised, topics like Afghanistan, nuclear accidents in the USSR, Russian atrocities in South Africa and the like are taboo.

The second task - to defame the people of the captive nations - is also well-organised and co-ordinated from Moscow. This action has gained momentum lately. Almost daily the media carries stories about 'criminal' and 'Nazi' war activities, but seems reluctant to publish much in defence of these allegations.

The extent of Moscow's influence can be seen in this example. Valentyn Moroz, a long-serving political prisoner in the USSR who underwent mental and physical torture in prison camps and psychiatric institutions, is now in the West. He continued his work for Ukrainian independence by joining Radio Free Europe. His programs for Ukrainians were very informative of the actions perpetrated by Moscow's imperialists. Apparently he did his job too well. For some inexplicable reason he was removed from his position. On the other hand Russian radio daily broadcasts the most outlandish propaganda against America.

Even in Australia it has been known for a prominent so-called "right wing" journalist to lose his job for being consistently critical of the Russian empire and for defending its subjugated nations. What a clever tactic. To deter any would-be captive nations sympathiser from pursuing this line he can be threatened with the loss of his job. Unfortunately these subversive tactics are supported by any number of Jews even though at present there are close to 3 million

Jews suffering oppression in Russia's prison of nations, without much hope of being allowed to leave.

Another person targeted by Moscow was Lev Futala-Lahidnyj. Before he completed his schooling he joined the Ukrainian Insurgent Army (UPA) to defend Ukraine against the German, and later the Russian, imperialists. On the 11th of September 1947, after a 99-day journey on foot with no outside support, his UPA group, under the command of Captain Hromenko, made it to West Germany.

Once in the free world Futala continued working for the independence of Ukraine. Moscow then decided to discredit him. A Jewish newspaper claimed that Futala was a war criminal and a Nazi, and even though that same publication eventually published an apology the damage had been done - both Futala and Ukrainians in general had been tarsed with the brush of Nazism.

In the spring of 1986 the Jewish newspaper "Village Voice" in New York, America, published one and a half pages of accusations against a high-standing member of the Ukrainian nationalist movement, Mykola Lebed. Ukrainians both in Ukraine and in the diaspora were embittered to learn of this repugnant article. Who is Mykola Lebed and what was his role?

As a student Lebed joined the patriotic Organisation of Ukrainian Nationalists. Soon he was part of the executive council of the OUN which had tens of thousands of members. Because of his nationalistic work and impending arrest he escaped to Germany.

The Nazis captured him and handed him over to the Polish authorities for what was certain death. And sentenced to die he was, but this was commuted to life imprisonment. During the war he managed to get out of prison and continued his work for Ukrainian independence.

When Hitler resolved to advance on the Russian empire Ukraine was then undergoing unprecedented sadistic persecution. Literally millions of people were transported to prison camps in Siberia. Only a few years earlier 7 million people had died of starvation during Moscow's planned famine. The retreating Russians left prisons full of murdered Ukrainian political prisoners in all of the larger towns. In the town of Vynnitsia there was a park which had for a number of years been fenced off and signposted "Security Zone". The bodies of 9,000 executed Ukrainians were later found there.

Because of these horrendous circumstances it can be understood why the majority of Ukrainians welcomed the war and the advancing Germans as civilised European liberators against the brutal Asiatic-Muscovite enemy. Within days almost 4 million soldiers (from the Soviet army) voluntarily gave themselves up to the Germans and were prepared to fight with Germany to liberate their countries from the Russian prison of nations.

Hitler, however, had other ideas. At that stage he was at his most triumphant as overlord of his empire, and his Gestapo acted with much less than European civility. The leaders of the underground movement in Ukraine were aware of Hitler's true plans and so they made a gallant stand and proclaimed the restoration of Ukrainian independence on June 30, 1941 in the capital of Western Ukraine, Lviv. This act, taking place during the first days of battle between

two empires on Ukrainian soil, was a great moral victory for Ukraine. It was spontaneously accepted by the people of Western Ukraine (Eastern Ukraine being then occupied by Moscow) who immediately began to reorganise their lives around Ukrainian independence and freedom.

This proclamation caught the Germans unawares but Hitler ordered the immediate arrest of the leader of the movement, Stepan Bandera, and the Premier of the newly-restored Ukrainian state, Yaroslav Stetsko. The entire command and thousands of active members were also arrested. These arrests revealed the true plans of Hitler to the Ukrainian populace.

One of the members of the OUN hierarchy who managed to evade arrest was Mykola Lebed, who went underground and then began organising armed resistance against the German occupiers, being instrumental in the formation of the Ukrainian Insurgent Army. At this point Germany showed its true colours and began its own campaign of terror in Ukraine. Meanwhile the Ukrainian Insurgent Army (UPA) grew to number tens of thousands of underground soldiers who countered German action. Bridges were blown sky-high; the German theft of wheat, cattle and slaves for the German workforce was greatly hindered.

The Gestapo in Berlin were ordered to catch Lebed at any cost. This order was passed on to each Gestapo post in occupied Ukraine. A copy of this order now exists in the Ukrainian archives in the west.

The vocal campaign in search of Nazi war criminals after 40 years gives rise to certain questions. Is it possible that the Nazis were somehow able to force some Ukrainians into persecuting the Jews similar to the way in which they used some of the Jews from the ghettos? Could Russia, helped by the Jews, have

## convinced Ukrainians to destroy Ukrainians?

When certain elements began to accuse Mykola Lebed, and also Yaroslav Stetsko, - two of the strongest opponents of Nazi Germany - of Nazi war crimes, then it became absolutely clear that the campaign had its roots in Moscow. The more so when one knows that exactly the same campaign is being waged in Ukraine by the KGB.

#### WHO WAS YAROSLAV STETSKO?

When Ukraine, after battling Russia and Poland, found herself after World War I without an independent state, her patriotic youth, under the leadership of a senior officer of the Ukrainian Army, Colonel Yevhen Konovalets, began forming itself into groups which together made up the Organisation of Ukrainian Nationalists. Their aim was an independent and sovereign Ukraine.

At the commencement of World War II the OUN had tens of thousands of dedicated and committed members who had been well schooled and were prepared to risk their lives for their country. As well as this millions of fellow-Ukrainians were sympathetic to the OUN. The first leader of this organisation, Yevhen Konovalets, was assassinated by a bomb in 1938 in a street in Rotterdam by two KGB agents -Valuch and Polovedko. Yaroslav Stetsko had joined the OUN while still a young student and when war came was on the executive committee. The Organisation of Ukrainian Nationalists had planned, since the first day of German occupation, to proclaim Ukrainian Independence and show the Germans that Ukrainians would only be satisfied with being in control of their own country on their own territory.

This proclamation was very heroic as it could have meant certain death for those involved - something which they quite expected. Hitler could have had them all executed. In a number of days, many of the leaders were arrested and sent to concentration



Yevhen Konovalets Assassinated April 23, 1938 - Rotterdam


camps, among them Y. Stetsko, who was kept imprisoned until the end of the war. Those leaders not caught by the Germans led their members into battle against the armies of both European empires.

Yaroslav Stetsko was a consistent and tireless fighter for Ukrainian independence for over 50 years. He dedicated his life to this cause. This great patriot and wise politician was, until his recent death, the leader of a great mass of patrictic Ukrainians in the diaspora and the hope of the 50 million-strong Ukrainian nation. He was also the President of the Anti-Bolshevik Bloc of Nations (ABN) which represents all the nations captive in the Russian empire. This organisation has developed great credibility in the western world and is being treated seriously by a number of world leaders.

Stetsko was also in the Executive Committee of WACL (World Anti-Communist League) and APACL (Asian Pacific Anti-Communist League). It is the very ideas and work of these organisations which can lead to the downfall of the Russian empire. That is why Jewish communists, with advice, and possibly financial rewards from Moscow, are so strongly attacking Stetsko and the anti-communist independence movement. Thanks to this movement and Stetsko, recognition and respect has finally been forthcoming for the tragedy of the Ukrainian holocaust. Calling Stetsko a Nazi war criminal is as unrealistic as calling Peres (Israel's premier) or Begin agents of the Arabs.

Why are Moscow's agents trying to blacken Stetsko's name with the tag of Nazi war criminal? Because the leaders of the Ukrainian resistance are as dangerous to Moscow today as they were during the war when UPA fought against two great empires without any foreign help. To bring them down from positions of respect and authority, and to render them incapable of speaking for the Ukrainian people, they have to be compromised and their reputations blackened.



To aid her anti-Ukrainian campaign, Moscow makes full use of her "useful idiots". Helped by left-wing parliamentarians, who for the past 40 years have worked parallel with the fifth columnists, directives from Moscow have resulted in action for "justice". Slovaks, Serbs, Slovenes and Croatians all had diplomatic ties with Hitler's Germany and are thus branded as Nazi. By the same token communist Tito's criminal activities and his government's responsibility for the deaths of thousands go unjudged, the argument being that certain actions are necessary for the progress of mankind – and thus they were whitewashed:

What about seeking justice in the actions of Chamber-lain and his royal cohorts regarding Hitler? Why are the concerned not so concerned in the justice of the Moscow-Berlin pact which started World War II? The crimes of the Russian empire far outweigh those of Hitler. Is the mass murder and forced resettlement of thousands of Latvian, Lithuanian and Estonian people to Siberia to go unjudged? When will the perpetrators of Katyn be brought to justice? Is the deliberate creation of a famine in which more than 7 million people perished not a crime? Are the executions of civilians in Lviv, Drohobych and Vynnitsia not a crime? Who will be judged for the forced resettlement in 1947 of 1 million Ukrainians from the Lemko region?

Is it enough to say that the lives of 20 million Ukrainians taken by Moscow over the last 60 years was a necessary step for the "advancement of mankind"? Do Moscow's stooges have an "explanation"? Do the "useful idiots" realise what they are doing? Are they aware of the millions in prison camps? Why are these seekers of "justice", many of them with union connections, not seeking justice for the workers in the Russian empire who are harshly controlled and blatantly used? Where are their voices against the injustice of banning a 10 million-strong democratic trade union in Poland?

Naive and misinformed stooges are Moscow's best weapons. Another couple of Chamberlains and Moscow will have conquered the West without firing a shot.

Jewish influence in North America is so strong that both Canada and America, notwithstanding the fabricated and unverifiable documentation from Moscow which was produced as evidence, gave in to the pressure and are officially preparing to try individuals from the captive nations.

In Australia government officials are preparing to follow the American lead. Yet during the war Australians suffered greatest under the Japanese. Why is there no campaign to identify and punish former Japanese concentration and work camp overlords?

#### SOVIET RUSSIAN CRIMES AGAINST HUMANITY

Hitler's brutal Nazi regime was destroyed 41 years ago and many of its criminals brought to justice. The time approaches for a new Nuremberg - and the punishment of Moscow's criminals.

Is it not time to put the Russian empire on trial for the following:

- 1. The subjugation and destruction of many nations.
- Mass deportations of people from their homelands and their resultant deaths in the Siberian concentration camps.
- 3. The man-made famine of 1932-33 in Ukraine.
- Mass executions in Vinnytsia, Katyn, Lviv, Drohobych and other towns.
- 5. The bloody deaths of countless Polish patriots in the Warsaw uprising.
- 6. The murder of thousands of migrants and refugees "repatriated" to the Soviet Union after W.W.II.
- 7. The murder of captured Germans, Japanese and others.
- The deliberate destruction of the language and culture of other nations.
- The brutal liquidation of the Ukrainian Catholic and Orthodox churches; the execution of thousands of priests, bishops and faithful.
- The large-scale slaughter of the Ukrainian population during UPA's 10-year campaign.
- 11. Various trials against Jews, and the denial of their freedoms.
- 12. The destruction of the noble Wallenberg.

- 13. The assassination, in the free world, of the Ukrainian leaders Petlura, Konovalets and Bandera, and the bestowing of medals of honour on the assassins by Moscow.
- 14. The destruction of patriots of the captive nations by brutal treatment in psychiatric institutions.
- 15. The wholesale killings in Afghanistan.

Is it not pertinent here to add Moscow's latest crime - the building of substandard nuclear reactors in close proximity to the capital cities of Ukraine and other captive nations?

After the nuclear catastrophe at Chernoby, near Kyiv, the Russians secretly evacuated their own people. Meanwhile the Ukrainians were made to dance in the streets for the benefit of the western press. Ukrainians were neither warned, nor given any information as to the severity of the situation. The passing on of information verbally was punished as a crime of 'capitalist propaganda'; and still thousands of Ukrainians continue to live in contaminated areas. And so the genocide of Ukrainians, by any means, continues.

It is high time that the west stood in defence of the captive nations. It is high time that the west confronted today's criminals and murderers, instead of being fooled by them into a wild-goose chase.

#### UKRAINIANS ARE "NAZIS AND ANTI-SEMITES"

Time after time newspapers, journals and even television programs depict Ukrainians as Nazi anti-Semites. Even worse is the way Ukrainians are represented in fiction – in novels written by some Jews or Moscow's com-rades. Reading a few of these books it would seem that the perpetrators of atrocities which claimed the lives of millions were not Hitler's Germany or communist Russia but Ukrainians.

You could be forgiven for thinking that there are no longer any Jews in Ukraine and that none would even want to live there. The fact is that when in 1948 the Jewish nation state was being formed the number of Jews living in Ukraine was many times that of the Jews who lived in "God's chosen land", Palestine.

On orders from or under the influence of Moscow certain Jewish groups with control of or access to the media are dishonouring the name of the Eastern European nations, particularly Ukraine.

From the time of the Nuremberg trials to this day countless criminals of the German empire have been brought to justice - 6,479 have been sentenced to either life imprisonment, other terms of imprisonment, or death - yet not one Ukrainian has been among these. This fact little interests the fifth columnists who know only that Ukraine is a danger to communist Russian imperialism and must be continually weakened.

A quick look at Ukrainian-Jewish relations in the 20th century might be of interest. It is an historical fact that Tsarist Russia held pogroms against the Jews and chased them out of Russia. Ukraine, in those days occupied by Russia, had a population of hundreds of thousands of Jews, many of whom lived very well.

Eventually the new Jewish nation was to be governed by Jews from Ukraine - Golda Meir, Moshe Dayan and others - who grew up on Ukrainian bread. Notwithstanding the great attraction of life in Ukraine the prominent Jews worked not with Ukrainian leaders, but with the occupying Russian powers. They collected taxes for them and had great powers over the Ukrainian populace - they were even in control of the Christian churches. One had to pay the Jew to open the church, be it for prayer, a christening, a wedding or funeral. It follows that the Ukrainians did not take kindly to this control and power.

When the tsarist empire was overthrown and Ukraine proclaimed a democratic independent nation, Jews were granted the right of ethnic autonomy and had their own Ministry in government. At that time, however, world Jewry was resolutely building international communism and Ukrainian Jews did not stand by Ukraine, but supported Lenin and the Moscow politburo which was then under full Jewish control.

In 1918, of the 62 members who made up the Central Committee of the Communist Party, 42 were Jews. In the Ministry of Police, of the 22 members, 16 were Jews. In 1935 the membership of the Central Committee of the Communist Party was 59, and 56 were Jews.

It is quite plain why the majority of Jews joined sides with the Moscow politburo against Ukraine.

When Ukraine lost her newly-found independence to Russia's Red Army, a Jewish assassin, Schwartzbart, was ordered by Moscow to kill the leader of the Ukrainian nation, Symon Petlura, in Paris.

(See Appendix A: A Jewish/Polish view of Petlura.) Now, under the occupation of the Russian politburo, Ukraine experienced a terror unheard of in history. SYMON PETLURA Leader of the Ukrainian nation. Assassinated by communist Jews in May 1926.

LAW
concerning
JEWISH COMMUNITY SELF-GOVERNMENT
accepted by the Cabinet of Ministers

I. The enclosed Statute of Jewish Community Self-Government, which changes, supplements or annuls the laws in question, has been approved.

- II. The Jewish Community Councils, existing at present on the basis of the Law of December 2, 1917, continue their work by virtue of this Law until election of new Jewish Community Councils, which shall take place within two months from the day of promulgation of this Law.
- III. Within two months from the day of the publication of this Law, the following institutions shall pass over to the jurisdiction of the respective Jewish Community Self-Government Organs:
  - 1. All Jewish educational, welfare, sick-nursing, and sanitary institutions. which do not belong to private persons, societies or associations, and which function on the basis of special Statutes or without any Statutes; likewise, the Jewish institutions which on the basis of general or special laws are being managed by, or in whose management are participating city or provincial administrative organs, or the autonomous organs of the provinces, districts or villages.

Note: All state Jewish educational and scientific establishments together with their property and inventory that belong to them or are entrusted to them as well as the Jewish State schools, teachers' colleges and other educational institutions are to be given to the Ministry for Jewish Affairs for administration.

- All capital and all inventory that have been and are at the disposal of, or have been assigned to, the Jewish institutions mentioned in Article III, 1.
- Jewish cemeteries.
- Note 1: Fund needed for the organization and maintenance for institutions mentioned in Art.III shall be appropriated by State Treasury and by city organs, and shall be transmitted to the Ministry for Jewish Affairs or to the respective Jewish Community Councils for their disposal.

Having built a democratic, vibrant national life under their newly-found freedom, the people of Ukraine reacted to their new overlords with strong opposition. Two Ukrainian quislings of Moscow, D. Shumsky and M. Khvylovyj, who believed that Moscow was working for a better communist Ukraine but eventually realised that she was only expanding her empire, committed suicide. They were replaced by L. Kahanovych as Secretary of the Communist Party of Ukraine and I. Shelehess, A. Shlihter, Y. Rahkis, among others, as assistant secretaries. All of them were Jews. The following Jews held positions in the Ministry of Police - V. Balicky, Karlsom, M. Latsis, F. Koch, C. Fuchs.

L. Kahanovych realised he would have a monumental task in bringing the Ukrainian villagers to heel. They were hard-working farmers, fiercely proud of their livelihood and land and would defend these to the death. Moscow's plan was to take all the land and reduce the villagers to virtual serfdom under the guise of collectivisation.

To achieve this, Kahanovych and the politburo organised a man-made famine in which 7 million Ukrainians died. Imagine that the head of Israel was a Ukrainian and that under his leadership 7 million Jews died. What would be the Jewish reaction?

A documentary on the Ukrainian holocaust, "Harvest of Despair", has won a number of prestigious awards. It has been bought by Australia's government television network. The suffering of Jews, much of it supposedly at the hands of the Ukrainians, gets repeated mention in the media. Why then hasn't the Australian public been shown the horror of Ukrainian suffering - particularly when its perpetrators are still in government and have not been brought to justice?

#### REGARDING THE FAMINE IN UKRAINE

As we know the 1932-33 famine was a tragic episode in Ukraine's history. While much has been written about it there exist many hypotheses which relate to the question "Why was this terrible famine created?". Why were so few people in the 'western' world aware of what was happening in Ukraine? An article by Kalenyk Lucyk in the 'Canadian Farmer', November 25, 1963 attempts to answer the question.

#### (Following is a reprint of this article.)

This question has interested me for about 30 years. I obtained what documents I could, about the famine, from government officials and government records in America, Great Britain, Germany and other countries. I also studied various publications of Senate committee investigations, press reports, articles by the Jewish historian Ayzbell, items in the Jewish press and the records of American senator Jack B. Tunney who was for eleven years chairman of a senate investigating committee. By this process I collected much information and material relating to the famine.

Everything printed here is substantiated by documentary evidence or affidavits of witnesses who were in Ukraine at the time and personally experienced the famine. I also collected many original photographs from the famine period which support the documentary evidence.

Government documents in the National Archives, Washington D.C., researched in Moscow as well as Great Britain confirm that the Russian revolution was planned and financed by American and European millionaires. One American

millionaire alone gave 20 million dollars for that cause.

The Jewish historian Ayzbell states that from 1917 Jews planned to settle Jewish masses on Ukrainian lands. To this end a special committee called "Agro Joint" was set up in America financed by American Jewish millionaires. Julius Rosenvelt together with John D. Rockefeller donated \$500,000 for this project. Members of the committee were: Louis Marshall, Myer London and Felix M. Warburg.


By 1924, fifty-nine million (\$59,000,000) dollars was collected to support this ideal. From 1924-29 a further eighty million dollars (\$80,000,000) was collected, most of which financed the project of settling Jews in Ukraine. (Source: "Zionist Network", Jack B. Tunney, page 56.)

By 1930, 250,000 Jews had been settled on 162 agricultural properties consisting of 9,526 individual farms. (Source: Ukrainian-Jewish Mutual Relations, O. Bryk, page 142.)

Jewish publications, "Jewish Anti-Communist" page 6 and "The Jewish Question" published in 1931 record that the makeup of government administrations in the early years of the USSR were as follows:

1917-18, 316 commissars of which 300 were Jews 1920, 457 commissars of which 322 were Jews 1921, 550 commissars of which 447 were Jews 1922, 525 commissars of which 445 were Jews.

Having the majority in the USSR administration, the Jews were involved in all decision-making



including the settlement of Jews in Ukraine and Crimea, plus the plan to build "Zion" in Ukraine. Planning of the Ukrainian famine was still a few years in the future. Disarming Ukraine with a false promise of amnesty and further intimidating the populace by judicial process, Russia then took steps to implement the "famine plan". The Jewish farmers were warned in advance and they left their homesteads moving to the nearby cities and villages. The Jewish population did not starve as the warning enabled them to store food in anticipation.

In 1933 the majority of European and American press, controlled by the Jews, were silent about the famine. If some newspaper reported on the famine it was immediately contradicted and reported that "Under Soviet rule there is no famine and surplus is being exported. Famine exists only in the minds of the enemies of Soviet Russia."

To divert attention from the Ukrainian famine the USSR in 1933 planned an indictment of British engineers in Moscow. The most accurate account of these events was reported by a British correspondent who attended the trial. His article "Moscow Trial" in 1933 records how they were forbidden to travel to Ukraine or write about Ukraine on the pretext of secret military installations there. Correspondents in Moscow ate like royalty. All the reporters from the "free press" could not understand the purpose of the trial or the reasons behind it, but they suspected that it was to camouflage some other event.

For the Russian elite and patriots such Jewish ambitions were unacceptable particularly since

it was suspected that Tychachevski was the source of rumours attacking Stalin. Stalin uncovered this "plot", liquidated Tychachevski and his cohorts and also purged the army, the communist party and conducted a purge throughout the USSR. From that time he also changed his policy relating to the Jews. Firstly, in 1934, he granted the Jews their "republic" - not in Ukraine or in Crimea but in Byrobijan away in the far east. In any case they did not remain there for long and the majority covertly left the region shortly thereafter. Stalin gradually relieved the Jewish administrators of their positions and replaced them with Russians.

Therefore the Jewish leaders' dreams of establishing a "Zion" on Ukrainian soil were thwarted. They were also unsuccessful in assuming control of the USSR which they helped create with their substantial financial support.

The legacy of this endeavour fell to eight million Ukrainian victims of the famine and this the Ukrainian nation will never forget!

It can be seen that many Jews and Russians had authority over the life and death of Ukrainians.

When Germany moved on the Russian empire, actually Ukraine, in 1941, retreating divisions of the NKVD (forerunner of the KGB) massacred tens of thousands of Ukrainians in political prisons.


The hope that the advancing Germans would act honourably towards Ukrainian interests died within two weeks. The Gestapo began their own mass arrests and executions of Ukrainian patriots. The Ukrainian police, who weren't very co-operative about providing the Germans with the grain and cattle they demanded, not to mention slave labour for German factories, soon found themselves in disfavour and in danger of trial and execution. Many of them ran away to join the underground Ukrainian partisan army (UPA), which the Germans called a communist agency. It is interesting to note that the famous Nazi-hunter, Wiesenthal, himself admits to being saved by a Ukrainian policeman.

In World War I many Ukrainians served either in the Austrian, or Russian, imperialist army. By making use of this officer training and the available weapons, Ukraine was able to successfully proclaim her independence. Young Ukrainians now began to ponder on similar possibilities - where could they undergo army training and have access to much needed weapons? The UPA was short of arms and could not have coped with the thousands of young patriotic Ukrainians willing to take up arms in defence of Ukrainian independence.

In 1943 Germany's imminent defeat on the eastern front was obvious. The idea was mooted that a Ukrainian division be formed alongside the German Army. This agreement with the German army command was that this division would be used solely against Russian imperialist forces and on no account against the Western allies. Thus in a time of great turmoil, confusion and tragedy, Ukrainians attempted to fight for their nation honourably and with regard to all the participants of the war.

The Ukrainian holocaust and the Jewish holocaust, perpetrated by Russia and Germany, were the greatest atrocities in the history of mankind. To try to implicate Ukraine in the Jewish holocaust is the basest of propaganda efforts and beneath contempt.


Hitler was responsible for the deaths of thousands of Ukrainians in prisoner-of-war camps. They had either been captured or, most likely, surrendered from the Red Army only to die of starvation. Hundreds of thousands of Ukrainian youth were literally hunted down to be sent to Germany as slave labour.

Thousands of patriots were executed or hanged in public places; others were sent to concentration camps - often the same ones thought of as exclusively Jewish concentration camps.

The Ukrainian Insurgent Army saw a daily increase in its numbers and in 1943 had, in various formations, tens of thousands of soldiers who daily waged battle, along the length and breadth of Ukraine, against German soldiers and police. The ranks of UPA also held many Jews, mainly as doctors and medical orderlies, and there they had a greater chance of survival.

The prince of the Ukrainian church, Metropolitan Sheptytsky, saved many Jews at the risk of his own life and that of his clergy, nuns and followers.

My own mother together with other neighbourhood wives for almost four years fed Mindlia Baizen, a Jewess from the village of Lubno, who hid in the nearby woods in gullies, surviving those terrible years. A Ukrainian policeman, O. Troyan, and I managed to rescue her at one stage from the Gestape - a fact

well-known in the area. There were many similar cases.

It is unknown how many Ukrainians were persuaded by the Gestapo to work against the enemies of Germany, but we do know that Russia forced quite a large number of Ukrainians to work with Russians and Jews in the destruction of Ukrainian patriots. In a similar way the Germans organised Jewish police as guards in the ghettos. In the years 1942-43, I lived in the town of Peremysl near a Jewish ghetto and saw some tens of Jewish police with large stars on their sleeves. Such units were made up of weaker types who acted quite cruelly against their own brethren.


Each nation has its weaker element. This becomes more evident under harsh conditions such as a country's enslavement, or deprivation and terror. Yet if we are to make these people answerable for their actions we should not make nationally based exceptions, such as Jews who committed crimes against Jews.

We are often told by Jews that near Ukraine's capital, Kyiv, at a place called Babyn Yar, Ukrainians helped the Germans massacre 33,000 Jews. This "fact" is often bandied around, adding to the vilification of Ukraine's reputation. The reality of Babyn Yar is that the Germans massacred 100,000 people\*, a number later verified by post-war commissions of inquiry. Take away 33,000 Jews and one is left with 67,000 Ukrainians! Yet for some reason it is a number that world Jewish outrage is loath to publicise.

Among those sacrificed at Babyn Yar is Ukraine's greatest sports team. The Germans, to help boost their soldiers' morale, had brought over their best soccer team to play against the Kyiv Ukrainian team. Before the game the "untermensch" Ukrainians were ordered to lose the game, but the brave and defiant Ukrainian team beat the Germans 5-0, and were all executed at Babyn Yar.

Ukrainians suffered greatly at the hands of Germans: over 3 million prisoners of war died of hunger in the camps; hundreds of thousand were forcibly transported to Germany as slave labour for factories and farms, and many of these died during the bombardments; in retaliation for UPA's resistance the Germans executed masses of innocent people and burned many villages; in most towns loyal Ukrainians were hanged on public gallows. Overall the conflict with Germany cost Ukraine 10 million lives – yet this death toll is not only ignored by the Russians and Jews, but suppressed.

The conspiracy of silence practised by Russia and her Jewish sympathisers hides much more. In 1932 the Jewish journalist Duranty was sent from the U.S. to check up on the rumour that there was a colossal famine in Ukraine. Duranty, later given one of the highest awards in journalism, falsely and deliberately denied the "rumour", writing about a rich and flowerbedecked Ukraine. Meanwhile the truth of the situation was being recorded by journalist Malcolm Muggeridge, yet it was concealed from the pages of the world press. Only in the last few years, when concealment became impossible, has Muggeridge's report received any sort of publicity.

Even recently the disaster at Chernobyl, a potentially fatal incident for hundreds of thousands of new and innocent Ukrainian victims, has received poor coverage in terms of its relevance to Ukraine. Once again few journalists were permitted to travel to Kyiv. Russians were evacuated from Kyiv, while television showed Ukrainians in national costume dancing in the streets. In Australia one can see a parallel between the miserly coverage given to the latest Ukrainian demonstrations in Sydney and the demonstration in 1953 on the 20th anniversary of the famine. In whose interest are certain brutal facts and tragedies suppressed in the media?

During the last 70 years, regardless of the continual flux of foreign overlords, only two groups had influence over Ukrainians - the Ukrainian National Republic in the east, and the church together with OUN-UPA (Organisation of Ukrainian Nationalists/Ukrainian Insurgent Army) in the west. How many Jewish deaths can be attributed to these groups and their massive number of followers? More to the point, how many Jewish lives were saved thanks to these same organisations? Today Moscow makes sure that much anti-Semitic material is published in Ukraine. Should Ukrainians be held reponsible for this also?

In the years leading up to World War II life for Jews in Poland and Western Ukraine was paradise. During Hitler's holocaust Poles saved the lives of a great number of Jews. 1945 saw the arrival in Poland of the new "Polish" NKVD, many of whom 'could not even speak Polish. While this Russian/Polish police force had a hard time recruiting Poles to its ranks, Jewish groups joined to help destroy yesterday's Home Army freedom fighters and other military groups fighting the Germans.

These episodes are well-detailed in the memoirs of Dziura-Dziurski. In his work, "Freedom Fighters", one also finds information, provided by eminent Jews who lived through the holocaust, on the number of Jews who perished in the holocaust. This number is almost

half of that so widely publicised by the Jews today. He also writes about Jews who, having managed to avoid concentration camps, tattooed camp numbers on themselves prior to migrating to the free world so as to obtain compensation.

True, there are authentic Jewish memoirs, and many of them. Books by such people as A. Shifrin, A. Vudka and I. Kleiner. Anatoly Shcharansky, who only recently was let out of the USSR had this to say at a mayoral banquet in New York: "Just as Ukrainians, Armenians, Protestants, Catholics and Jews live together in solidarity in New York City, there (in the USSR) Ukrainians, Armenians, Christians, Catholics and Jews live in solidarity against the KGB". People such as this saw that collaboration with Moscow would lead to the ruin not only of the Jewish people, but of the whole world. Instead of servitude they chose the hard path - Russian concentration camps - some of them for many years. Here they had the opportunity to befriend Ukrainians and others and honestly discuss the problems of the Jewish and Ukrainian nations whose fates have been so similar - no national recognition and millions of lives lost in their respective holocausts. The books of such people contain admiration and respect for the actions of the Ukrainian Insurgent Army. These works, however, are not popular in the West - not even among the Jews. Popular books with Jewish themes in the West are those fictional works which show Ukrainians, Estonians, Latvians, Lithuanians, Hungarians and others as "terrible Nazis". They are well-advertised and promoted, with a large readership. Why and by whom are they financed?


The Jewish campaign against Eastern European "Nazi war criminals" has been influential to the point of obtaining government and judicial action in America and Canada. The uninformed reader may obtain the impression that the people of the captive nations of

Eastern Europe, especially Ukraine, are the most perilous people in the world. The fact that previously Ukraine had twice the population of Russia and today has less than half, and the reason for this, doesn't interest anybody. Neither does the fact that since 1920 Russia has, helped by Jews, been responsible for the deaths of tens of millions of people.

Jews in Israel teach their children from the first years of school to hate Ukrainians for these imaginary crimes. They were annoyed that out of all these "criminals" not one had been tried for his "crimes". Finally in 1986, courtesy of Russian evidence, they caught one - "a second Eichmann", Demianuk. Much was made of this in the world press, and even more attention given to it in the Soviet press. Jews were shown in the streets of Israel dancing with glee. At the time of writing, this show trial has been postponed a number of times. Many witnesses say that Demianuk is innocent. His fate is uncertain. It seems unlikely that those who want Demianuk found guilty will be quick to let him go. For one thing, it would be a great disgrace for them, and secondly, there would be the possibility of a compensation payout.

Once again the question surfaces - why such a strident campaign, aimed solely at members of the captive nations, forty one years after the death of Hitler and the fall of his empire?

Forty years after the end of WWII more and more people are coming to the conclusion that Western world leaders, in listening to the wrong advice, made a big mistake in allowing the expansion of the Russian empire. Not only was it a mistake of policy but one of deed. The Western powers actively helped this expansionist activity. The ranks of those who see it as a mistake are growing considerably, among these people we now have politicians and advisers in positions



of power. One of these is the most distinguished President of the United States in our time. President Reagan and his adherents have realised the futility of past Western action and are now striving to contain Russian expansion and influence in the world. Reagan knows what great wrongs have been done to the captive nations and is now speaking out in their defence. had a historic meeting with the leaders of the ABN (Anti-Bolshevik Bloc of Nations, formed in 1943 under German occupation). A number of times he has mentioned and paid homage to the son of the top military leader of the UPA. This leader was killed in battle with the Russians in March 1950. His son was arrested still as a minor and has spent over 35 years in prison camps, and has now been sentenced to exile. only crime was that of being the son of a nationalist Ukrainian general. The west pays scant attention to these events, but the news of the decree by the President of the United States in support of the captive nations is widely spread through all the nations in the Russian empire and seen as positive moral support.

The Politburo knows that the West does not pose a serious threat, wanting only peace with Moscow at almost any price. It does, however, allot tremendous resources to combatting "dissenters", not the least of whom are 50 million Ukrainians. Thus the latest campaign in search of "Nazi war criminals" which is confined solely to people from the captive nations. In the empire these people are called Hitlerites and American agents. Moscow did not hesitate to produce billions of dollars of weapons against what was eventually a non-existent enemy - the West. Why then would she be any less willing to outlay limitless funds in the fight against her real enemy?

What is the intention of the campaigned-for trials? A country has its neighbours - friendly, tolerant or hostile, but the fate of a country rests mainly with

her own people. All through history people have been inspired to brave and heroic deeds for one's country. The Jews have their heroes, such as those at Massada. Each nation also has its degenerates and traitors. Once again the Jews have such people. They were particularly evident during the tragic events of WWII when many Jews, members of the Judenrat or Jewish police, acted cruelly and sadistically against their own in the ghettos. These same people are now living in Israel and America. Why are they not being sought for their criminal activity?

Let's imagine that shortly the captive nations will be putting Russia and her supporters on trial for the deaths of not a few, but tens of millions. Using the same criteria as the Jews are using in today's campaign, how many millions of Russians and their henchmen would have to be tried? No doubt each of today's captive nations will one day have its own "Wiesenthal". We believe that both in Israel and America there are communist criminals living today who, during the Ukrainian holocaust, were instrumental in its planning or active in ensuring that not even a few grains of wheat were harboured by Ukrainians, and that not a loaf of bread found its way from Russia to Ukraine. And what of the criminals who executed tens of thousands of Ukrainians in Vinnytsia, Lviv, Drohobych and other towns. And what of those who tortured countless Ukrainians in retaliation for UPA's ten-year battle against occupation?

The recent nuclear accident at Chernobyl resulted in an unprecedented concentration of the media on the USSR. There were some voices saying: "Good, it's just what the Russians deserve." But where were the analytical and well-researched articles pointing out that it was a Russian decision in Moscow to build a sub-standard nuclear plant near the ancient capital of Ukraine, Kyiv, on some of the richest agricultural

land? Where were the articles pointing out that once again Ukrainians will suffer - not by their own choosing but because they are ruled by Moscow? Why aren't the journalists pointing the finger at Moscow for compounding the crime by not advising Ukrainians of the appropriate measures to take? Why aren't Ukrainans told not to drink the water or milk, or eat fresh vegetables? Hasn't the media noticed that only the higher-echelon party members are being taken to safety to Moscow? And so the chain of suppression, death and destruction has a new link - Chernobyl.

It would seem that Jews, through many years of planning and massive financial input, have created a world monster. Apart from this they have done the West a great disservice by developing a large cadre of leftwing academics who for many years have preached leftist policies highlighting the "corruption and imminent destruction of the West". The communist empire begins indoctrination of its young virtually from the cradle while the parents can only suffer in silence. Children are brought up as Russian patriots and with a hatred for the West. Similarly, in the free world, a segment of academic education promotes the same hatred for the West.

Hitler's actions while doing a great wrong to the Jews and others also did a great wrong to the Germans. His ambitions resulted in the deaths of millions of Germans. After the war German lands were divided among a number of other nations. The shame of his deeds still has to be borne by today's, and perhaps tomorrow's, Germans.

The Jewish holocaust, while not taking away from its tragic dimensions, was nevertheless a brief event in terms of world history, with several positive outcomes. It brought the Jews worldwide sympathy, large compensations and their own state. During the holocaust no

country would accept Jews from Germany, so Jewish youth began planning the establishment of their own state. While Jews had previously been known in most armies as cowards, now, in support of their own state, they became superpatriots and heroes. The actions of the young Jewish generation of that time is one of the brightest chapters of their history.

The creation of an international communist state in Moscow was one of the greatest mistakes ever made in Jewish history. For when in 1935, 90% of the leadership was Jewish, in the 80's one is hard put to find them with a candle. Not only that, but Russia today, having made good use of world Jewry for her own ends, has joined the Arabs in a move to wipe out the Jewish state.

After the turbulent and tragic long years of Jewish history it seemed that finally, on attaining statehood, their troubles would be over. From the first days of settlement of Israel to this day the Jewish nation has been working in two directions.

The young and fiercely patriotic Jews enthusiastically with rifles on their backs began to build their national life on their own territory, often in very difficult circumstances. Jews of a different calibre began building their national lives in a country known for its wealth and strength - the United States of America. Here they were hugely successful in a variety of fields - universities, most of the media, banks, factories and in business. No doubt their successes would not have encountered any opposition if they hadn't begun imposing their will on America and then other countries through their media muscle.

Israeli territory, neglected for so many centuries, had been settled by the Arabs who, at the time of the creation of the Israeli state outnumbered the Jews. Another problem was that not all lands claimed by the Jews were included originally into the Jewish state. The once persecuted Jews from different countries now persecuted the Arabs, chasing them forcibly out of their territory. These Arabs, particularly the Palestinians, reacted strongly to this. More oil was added to the fire then by the Russians. And thus began the Middle East conflict, a possible World War III scenario. With American help the Jews won. They easily defeated the few newly formed Arab states. It would not have been a formidable task to overrun them and create an Israeli empire. Unfortunately for the new Jewish state the Arabic wastelands were showing increasing reserves of oil, a much prized commodity, and thus lifting the lifestyle and wealth of the Arabs to unimagined heights.

With new resources the Arabs begin to counter Jewish moves. They plan a holy war to liquidate the Jews. Meanwhile the refugee Arabs are not particularly welcomed by any other Arab nations. Instead they are held for years in refugee camps. Homeless and stateless they begin retaliatory action against the Jews. The Jews react to any Arab action on a grand scale, such as aerial bombings of the Palestinian camps with the resultant deaths of women and children. This is written up in the world press as retaliatory action for Palestinian terrorist actions. Moscow takes full advantage of the situation, selling the Arabs its outmoded military hardware and using the proceeds for its own military updating. Menaced by Arabs with Russian arms the Jews turn for help to America and are thus able to keep on top of the situation. Jewish-Arab hatred festers, and some Jewish groups would like to see the complete elimination of Arabs from Israel.

This absurd conflict grows daily. It's no longer a question of battle between two nations and their armies that can be settled by a treaty. It has now

blown out to a hot-blooded detestation of two nations for each other which affects even children. The Jewish press crows over its retribution in Lebanon. The fact that many women and children died in revenge for the deaths of a number of Jewish soldiers, or in repayment for a rocket that ended up in the sands of the desert, is not mentioned.

The continuation of the terror seems out of control. Each side, supported either by Russia or the United States, wants complete destruction of the other. The possibilities of a third world war are frighteningly real. It's time to stop this ridiculous and unthinking conflict. Once again, as when she was used to build the communist Russian empire, America is being blindly led into a dangerous and foolhardy situation.

In corroboration of the previous arguments the following excerpts, from the book The Life of an American Jew in Racist, Marxist Israel, are quoted. The author, Jack Bernstein, is a patriotic American Jew who spent over six years in Israel.

During World War II, in Germany ... elite Zionist Ashkenazi Jews worked closely with Hitler's Gestapo in persecuting the lower class German Jews and delivering them to concentration camps. Concerning Nazism/Fascism, please let me clear a point. Germans are an admirable people - I dare say even great. But in Germany, the general population were victims of the Nazis who through cunning and brutality gained power. In Germany, the average Jews were victims of the Zionist elite who worked hand in hand with the Nazis. Many of those same Zionist Jews who, in Germany, had worked with the Nazis, came to Israel and joined hands with the Zionist/Communist Jews from Poland and Russia.

It is the two faces of <u>communism</u> and Nazi-style fascism that rule Israel.

While America's farmers, small businessmen and laborers are struggling to survive, the U.S. Government, dominated by Zionist Jews, are draining the pockets and purses of American taxpayers to support Israel's socialist economy and war machine.

Since the Israeli government knows, and the favored Zionists know, that the Zionist pressure in America will ensure that America will keep sending them massive amounts of money, Israel's government and its favored citizens spend money like drunken sailors. This practice leads to inflation and eventually to an economic collapse. Comparing Israel to drunken sailors is unfair to sailors. Sailors spend their own money - Israel spends money it gets from America

After Israel declared itself a state on May 14, 1948, Israeli terrorism continued in an effort to push more Palestinians from their homes. Since 1948, 350 Christian churches and Moslem mosques have been destroyed by these Zionist terrorists. At this point, I wish to give this warning to all God-believing people in the United States, Christians, Moslems and Jews: The destruction of religion by the Zionist Jews is well underway in the U.S. In Israel, it has nearly been accomplished.

Tens of millions of people have been killed since the Zionist/Bolshevik Jews, backed by the Zionist Oriented Jewish International Bankers took over Russia. In the Mideast, these same Zionist/Bolshevik Jews are using the very same tactic: to route the Arabs from their land they

#### UNITED STATES OF AMERICA

America, a great and noble nation, was the saviour of many countries during two world wars. At present many countries count on America to come to their aid in time of military need, yet sinister forces are seeking to undermine the United States in this role.


A lot of different national groups reside in the United States. Some, like the Germans, are a formidable number. Others, like Poles, Czechs, Hungarians and Ukrainians make up only a few million. Their homelands and fellow nationals, under Moscow imperialist rule, are undergoing repressions and cruelty, even planned genocide. Yet these nations not only aren't helped by America, but often aren't even given moral support in their struggles.

Yet it was often the migrants from these very countries who by their hard work in the mines, factories and on the farms contributed significantly to America's great standing. How many American soldiers of Eastern European and other migrant backgrounds strived to keep the world free of tyranny during the two world wars?

The hard-earned money of the migrants was sent, under advice from the Jews and their associated newspapers, to help save the tyrannical empire which in turn had further control over its empire of nations. The captive nations, in their often superhuman struggle for independence and freedom, were given no help by the West. Even when Russian tanks rolled into the capitals of Czechoslovakia and Hungary, the learned advisors told America not to support the overrun nations.

The post-war problem of Japan, in which the Jewish advisors had less interest, was wisely solved. The post-war problems of Europe, specifically Germany, where Jewish advisory interests took a strong line, resulted in harsh and unfair measures. A whole nation suffered for Hitler's crimes by having its country divided and the coming generations will still be experiencing shame. Is there any way that the German nation can be physically and morally united without future bloodshed?

These same advisors have seen to it that Western radio broadcasts to Eastern Europe are censored and toned down. The so-called "free" stations are not free to broadcast what they want to the captive nations People in Ukraine have been reported as saying that Radio Free Europe and Voice of America sound as if they are organs of Moscow. Once again, then, the captive nations are not being given the moral and financial support they urgently need, yet Israel has no difficulty in milking American funds for its cause.



Over 2000 prisoners from the "Rotleberode" concentration camp were massacred at Gardelegen on April 13, 1945. Among them were 500 Ukrainians from Western Ukraine who had in 1942 been brought to Buchenwald, and then to "Rotleberode". Their fate was revealed by the only survivor, Valentyn Koval, a Ukrainian. In 1941 Koval was producing an underground publication against communism and fascism when he was caught by the Nazis. In 1945 during the Gestapo-led transit to Gardelegen he managed to escape from the ranks of the doomed prisoners, and in 1947 he was a witness at the American war trials against Nazi Germany. Koval now lives in the United States where he works as an editor.

Why should America be an enemy of the Arab world? How did Russia and her cohorts successfully involve America in such a senseless scheme? Who are the advisors to the American government?

The solution to the problem of Israel was straight-forward. The Jewish nation, as compensation for the holocaust, received at the end of WWII over 80 billion German marks. In those days that was an enormous amount. Over and above that Germany pays Israel over 100 million marks annually. The Palestinians expelled from Israel were given no compensation.

For the amount of money wasted by Americans, Jews and Arabs in the conflict, each Palestinian could have been made rich. A parcel of desert could have been prepared for settlement, surrounded even by botanical gardens. If the Arabs had been unwilling to give up such a parcel of land, then the well-compensated Palestinians could have been resettled throughout the Arab world where the language and religion is the same.

By the same token the Jews, who demanded the right to settle in various countries of the world, could have allowed the Palestinians to live in their own countrywhich they have inhabited for hundreds of years.

This solution, though late, is the only way to resolve the problem of the Middle East. It allows the right to live in one's own country and compensates the badly treated Palestinians. More importantly, it will stop Arab hatred and suspicion of the Western world as well as curtailing the funds pouring into Moscow's empire.

We counsel the world Jewish leaders to take stock of their actions of the last three thousand years - in particular those which previously led to Jewish pogroms.

#### RED COMMISSARS

The position of commissar in the Russian communist empire is one of the most powerful outside of the hierarchy of the politburo. The orders of the politburo are entrusted directly to the commissars - such tasks as the planned annihilation of national groups as was the case with the forced famine in Ukraine in 1932-33. Purges, executions, systematic destruction of nationalist opposition - all these are the responsibility of the commissars.

The commissars that are planted at all levels throughout the army are feared by all, from the privates to Red Army generals, such is their power. The March 1986 issue of the Russian journal 'Otchyzna' traces the career of one such commissar. This career was devoted to crushing Ukrainian nationalism, firstly during Ukrainian independence 1917-22, and then for many years following. For this Moscow recognises him as a hero of the empire.

The Ukrainian Soviet Encyclopaedia writes about him thus (page 225, volume 9):

Minz Isaac Israelovych (born 3.2.1896) - soviet historian, academic AN USSR(1946). Member of the Communist Party from 1917. Born in the village of Krynychkakh (Novopokrovsky region, Dnipropetrovsk oblast). Active participant in the people's revolution (1918-22). In 1926 he completed historical studies at the institute of red professors in Moscow. He majored in the history of socialism: revolution and civil war, the history of soviet society. His major works: "English intervention and the northern

counter-revolution"(1931), "The history of diplomacy" (volume 2, chapter 4; volume 3, chapter 8, 1945). Contributed to volume 2 of "The history of the people's revolution in the USSR"(1953).

Minz has this to say about himself ('Otchyzna', March 1986, pp.3-4):

In April 1917 I joined the communist party in the first ranks of the Red Army. I took part in the Soviet takeover of Ukraine and in the action of destroying the bands of Ukrainian bourgeois nationalists. I worked in the ranks of the Red Army originally as a private and later as a commissar of a string of divisions and spent my whole early military career at this task.

The author of the article A.Sapsaj writes the following:

An ordinary youth from the provinces at age 23 became a red commissar who with selfless devotion and determination worked for the victory of the revolution. His name is often mentioned by eye-witnesses in memoirs and archival records of the period.

The central archival collection of the Red Army in Moscow has documents pertaining to military conferences of the Kharkiv army from April 4, 1919. These records show that the division commissar, Minz, used his Red Army division to capture a Ukrainian regiment and an armoured train.

Sapsaj continues by saying that he feels Minz was the first authoritative official of the Soviet government in

Ukraine. He is similarly referred to in the archival documents of the Red Army.

Minz was born in Ukraine and lived there quite freely for many years at a time when Jews were forbidden to settle in Russia. During the time of Ukrainian independence the newly-formed Ukrainian government announced personal autonomy for minorities. Soon after it included state secretaries for Polish, Jewish and German affairs in cabinet. Minz, however, threw his lot in with the Russians and worked for the overthrow of the Ukrainian government. This accomplished he then devoted many years to the eradication of the Ukrainian underground nationalist movement.

Should not Minz and others like him be tried as a traitor and collaborator, and as a perpetrator of war crimes in which thousands died.

#### JEWISH SUPPORT FOR UKRAINE

To underscore the wrongful attitude of some Jews to the captive nations, in particular Ukraine, we cite the following two articles by the well-known Jewish activist and patriot David Belamud from Israel.

"SHAME TO UKRAINOPHOBES"
(As reprinted in 'Schlach Peremohy', 20.4.86)

This article is not a defence of the Ukrainian nation because it requires no defending.

The Ukrainian nation has endured more suffering and pain than most nations of Europe. Living on its own lands it has been continually devastated by various imperialistic expansionists such as the Muscovites, Turks and Germans, among others. The Ukrainians by their labours fed not only all those that lived within their borders but also all of Europe.

Ukrainians never aspired to conquer foreign lands but other nations continually attacked and occupied Ukrainian territory. The Ukrainian nation has offended no-one and is beholden to no-one. Other nations are responsible for base and intolerably hostile attitudes to Ukraine's history, language and culture.

Without reference to these offences against their nation, Ukrainians offer a hand of friendship and peace to all nations with whom they have historically had contact, including the Jewish nation. It is painfully shameful to admit that Israel, which is the heart of the Jewish nation, to date rejects these attempts to peaceful coexistence of Jews and Ukrainians. This highlights the lack of dialogue on the problems of Jewish-Ukrainian relations and ignores the right of Ukrainians to have their own national state. It perverts Ukrainian history in the eyes of the Jewish community and misrepresents the stand taken by nationally conscious Ukrainians in the course of their history.

The blindness of Israeli leaders arouses indignation as they choose to ignore the Ukrainian independence movement which parallels the Jewish people's fight against Arab incursions, which are supported by the Moscow imperialists.

Israel cannot completely depend on support from the western democracies. In protecting their own interests the West betrayed Czechoslovakia in 1938, Vietnam in 1975 as well as many other nations and peoples. Apathy and political short-sightedness also appear in their attitude to the fate of our Israeli nation.

The Ukrainian independence movement does not require the support of Israel as much as Israel requires the support of Ukrainians. The Ukrainian people, by their own efforts and resources will regain their freedom. Our support of their just fight for independence is necessary not only to strengthen the state of Israel but also that we Israelis, above all, do not lose our self respect. It is impossible to build a secure future for our nation without ridding ourselves of our biased and unfair attitude to the Ukrainian nation.

In the name of the future nation of Israel and of our national integrity I raise my voice in protest against the divisive Ukrainophobes who sow seeds of dissent in Israel and the west. Shame to them that foster hatred for the Ukrainian nation. Shame to the vandals who desecrate Ukrainian monuments.

The time has come to stand in judgement of those responsible for the catastrophe visited upon the Ukrainian people - the starvation of seven million (7,000,000) during the 1930's.

"TIME TO RID OURSELVES OF COMPLEXES"

There were savage Jewish pogroms in the times of Khmelnytskyj and Gonta. Yet which country didn't practise pogroms against the Jews during the Middle Ages? There were pogroms during the Russian revolution. But were Ukrainians the only ones responsible? Pogroms against Jews were carried out by the reds, the Denikin white guard, Estonians, Latvians, Poles, Rumanians, etc.

Ukrainian policemen and camp guards worked with, or "collaborated" with, the Germans. But didn,'t others collaborate with the Germans during the war? Russians, Lithuanians, Latvians, Poles, Hungarians, Croatians, Slovaks, even the Dutch.

The accepted view in Israel seems to be that a Ukrainian is a Jew-murdering anti-Semite. Any cases of humanitarian behaviour towards Jews in Ukraine have been credited to the "Russian intelligentsia".

During World War II there were many Ukrainians who saved Jewish lives, yet why do we count so few of them in the Garden of the Righteous at Yad Vashem? This question should be asked of those Jews who were saved by Ukrainians and yet who, forty years after the end of World War II, are afraid to immortalize their saviours. Why? Because to say something nice about Ukrainians in Israel is dangerous. The Israeli press gave wide publicity to the extradition from the U.S.A. of Demianuk. It also pointed out that on April 13, 1985, a tree-planting ceremony which commemorated a group of Ukrainians who had saved Jewish lives, was attended by a member of the Knesset, Shevach Wise, and rabbi David Kachane. These two survived because they

were saved by Ukrainians. Yet the ceremony was held in relative secrecy and without the press, because they were embarrassed as to the nationality of their saviours.

As Ivan Demianuk's trial approaches they are trying to brush all Ukrainians with the collective tar of guilt. From the list of supposed Nazi war criminals why pick a Ukrainian for trial in Israel? Why not insist on the Rumanian, V. Tryfu? Or the Croatian, Artukovich, or others?

More frightening is the anti-Ukrainian atmosphere in which the young are educated. Ask any young student what he associates with the name Ukraine and his answer will be: Khmelnytskyj, Petlura and policemen.

Forty years after the Holocaust we have broad ties with Germany. With Spain (ignoring the Inquisition) we have diplomatic ties. Israel is also repairing its diplomatic ties with Poland. As regards Ukraine our learned leaders tell us that when Ukraine attains independence, then they'll establish ties.

To avoid new pogroms we must prepare the foundations for normalised relations. Ukrainian communities both abroad and in Ukraine now have a new generation free of the complexes of the past. This is testified to by the Jewish political prisoners who spent time in Russian prison camps with Ukrainians. It is now our turn to rid ourselves of these complexes!

### THANKS TO UPA I STILL LIVE!

That I live today and devote the energies of my 38 years to Free Israel, I owe to God and the Ukrainian Partisan Army (UPA).

To God, who gave me wide blue eyes and golden hair the shade of Ukrainian wheat. I was born in a small town, B.(to protect the living, identified by initial only), which lies 75km from Lviv in West Ukraine. My father was a respected man, not only by Jews, but by all people. He was a just man, who kept God's Law and loved his own faith and people, but respec-No wonder that he had ted the other man. therefore a friendly relationship with local Ukrainian Catholic priest, whom he visited for Old Testament "discussions". The priest's daughter (Ukrainian Catholic priests could marry then) was my best friend at school. When I had my Primary schooling completed, my father enrolled me in the Ukrainian Secondary School, though there was a Polish State School in town (West Ukraine was then under Poland). Papa had said - "in Ukrainian school you will suffer less discrimination". How wrong he was, using the word "less". In eight years of secondary school, my class mates treated me as an equal and as a Ukrainian. There I came to really know the Ukrainian national spirit, and in time I hated her enemies and looked towards her friends. At home I was brought up under the Old Law and we did not speak Yiddish but Hebrew. My parents inculcated early, a love for Israel in me, that Ancestral Home, subjugated as it was, like Ukraine.

In June 1939 I received my doctorate, and on September 28th my ship was due to sail to Palestine. On 1st September, 1939, war erupted, and I had no time to leave Lviv. The new occupiers, the Bolsheviks, at first treated Jews in friendly fashion. I received work immediately in a Secondary school, though I kept silent about my socio-economic antecedents. A year did not pass, however, as one morning the communist militia appeared and ordered me to pick up a few of my clothes and go with them for a trip. "What trip?" I asked, showing them my passport and papers. This was useless. An order had arrived from Moscow to evacuate all Jews to Siberia.

I dressed in my warmest and best, and awaited fate. Just before departing with them I asked to go to the toilet. That's when deliverance came to me. I lived on the ground floor and a window opened up on a side street. I jumped out and quickly ran away. Then until the Bolsheviks left, I stayed with my friend Olia, who had a flat then in Lviv (the daughter of B's priest, and my school friend). Olia worked as a clerk in a food store and barely earned enough She shared her last to feed the two of us. crust with me and treated me as a sister. though threatened by my presence. We had both been left without family. Her mother had died young and her father, though a priest, had been killed during the war by the Poles - the socalled Death Legion that had been formed out of criminal prisoners freed on condition joined a punitive battalion out to terrorize Ukrainian villages and kill prominent persons.

When the Germans entered Lviv I could have been the only Jewess to welcome their arrival. I

thought they might now establish a Ukrainian state and then go on against the Bolsheviks. How wrong I was, as my joy soon turned to terror. What the Germans committed on the Jews, they continued to practise on Ukrainians as well - in no way different to the Bolsheviks.

I still lived with Olia, whilst working as a seamstress for Ukrainian households. My documents carried a Ukrainian surname, whilst my face was not arousing suspicion. Each day I saw the columns of Jews who meekly went to their deaths under the supervision of a few militiamen. I fumed at this weakness, gritting my teeth in order not to cry out "Throw yourselves at them and kill the few guards, as you outnumber them by far!". Should a few die, as heroes mayhap, they would not expire as slaves. I often discussed this with Olia, but she said to me that Jews were not capable of heroism, and then I agreed with her.

"Oh, Olia, if I could relate to you how heroically the sons of Israel can fight or die, but you probably can see that....?"

Life in Lviv became dangerous for Ukrainians also. The prisons filled with Ukrainian youth and intelligentsia and even villagers. Frequent executions or arrests and transportation to concentration camps became rampant. But Ukrainians were not all meek, and blood they repaid with blood. Even then I heard news of a Ukrainian Partisan (Insurgent) Army, the UPA, active in the province of Volyn. Gradually that movement grew on all Ukrainian territories in the West taken by Germans. I began to realise, also, that Olia had links with the UPA, as she either typed up political broadsheets or disap-

peared for weekends, returning dishevelled and exhausted. Then she proposed that I too join her in the UPA. I thought it was an avenue to salvation, and I was gripped with hate towards the enemy. This was November 1943. As we wound our way along a clandestine route to the mountains, I asked Olia how she had introduced me to the recruiters - as a Jewess or a Ukrainian. "Don't fret" she replied, they do not divide people along racial lines - only into the upright and the collaborationists (i.e.with any invader). That day I joined the heroic UPA.

Until July 1944, we stayed in hilly areas near Lviv. There I underwent a three week nursing course conducted by two Jewish doctors and one Ukrainian. In our group at the time, there were 12 Jews, eight of them doctors.

When in July of that year, in fact, the Bolsheviks returned to Western Ukraine once more, I
received orders from the UPA to reside in the
town on R. and work for the Soviet militia. My
commander was a Jew, a communist and a zealous
party man. I simulated sympathy for communism,
whilst telling stories of ghetto life and the
Bolshevik "liberation". The commander sympathized, even began to court me, which I went
along with. All the while I liaised with the
UPA and passed information.

One day I was surprised at a rendezvous with my courier by that very Bolshevik commander. He attacked us. and thinking he had killed the courier, arrested me, carting me off to prison. Meanwhile, the courier recovered and tried to reach the Partisans on the outskirts.

I was kept in the local prison, improvised from left-over barracks. Only the old were there by then, as most of the young had joined the insurgents. Though beaten and tortured to extract information, I refused to talk. Sentenced to death, I joined 24 condemned in a room built for 12. One was a 70 year old grandmother sentenced to death for allegedly tending a cow too close to hilly UPA-controlled areas, in company with her 12 year old grand-daughter, thought to be a courier.

We often prayed together, as God must be one and the same. One night during prayers, loud disturbances outside the walls electrified us. In no time we were led outside by some of the boys and young men I had come to know in the UPA, as they had occupied the town and held it for 4 days. I went back to them and stayed in the group until 1945, when in the summer of that year we joined up with two others in the Carpathian mountains. We were safe for a while as the bolsheviks at first did not venture there, but by Ukrainian Christmas of 1946, eight months after World War II had ended, communist detachments surrounded our dug-out. We had even been provided with hand grenades for self-destruction at the last moment. The battle raged and we were nearly done, when another larger group of our Insurgents from over the other side of the mountains counterattacked and broke the ring. They had been told of our predicament by a young man who, as if miraculously, managed to carry the news across.


By the summer of 1946, our group met our enemy in even greater numbers. We were outgunned and my dear friend Olia was killed in battle. I was in the hospital, which was well concealed and not discovered. Our group of survivors - a doctor, a 77 year old priest and 5 invalids as well as I, waited it out with dwindling food supplies. Eventually the priest, Father Volodymyr, decided to try to reach a village and left us, though we doubted his fitness in our weak state. For two more days we scrounged the last bits of food, until the doctor said it reminded him of the famine deaths of his parents in 1933 near Kiev.

But that night death never came to us. A villager reached us with money and food, having been reached by the old Father Volodymyr. We were told to try to break through to the Western allies - through Czechoslovakia and Austria.

Taking time and great care we eventually reached the British Zone in Austria. There I bade farewell to my comrades in arms and continued on my trek to Palestine. But that is another story in my memoirs.

Now in my ancestral country I promised myself to inform the world if need be about Ukrainians and their heroic Ukrainian Partisan Army, UPA. For many years an opportunity never arose, as I was a grey nobody, listened to by no-one. Presently, as I have a position in the external affairs ministry and my signature is known by many a diplomat, I can do what I must. In ending this particular brief recounting, I turn to people of the democracies, not to dismiss the Ukrainian question and shuffle it off as a second or third rate matter. Only a free, independent Ukraine would bring security and demonstrate a truly just peace in the world.

Even in this article, written by a patriotic Jewess and heroine of Ukraine, we can see that Jews worked against Ukraine. The Jewish captain shoots the Ukrainian partisan and then arrests his own girl-friend for certain execution, because she fought against both German and Russian occupation of Ukraine.



Oleh Olshych

A scholar and poet. One of the most distinguished leaders of the Ukrainian nationalists. He was murdered by the Gestapo on June 9, 1944 in Sachsenhausen concentration camp. To counter falsified, misconstrued history as disseminated by the Russians and their "useful idiots" we present the following article by the late Yaroslav Stetsko. Stetsko, a world statesman who served time in a German concentration camp, was the Prime Minister of Ukraine during its short time of independence at the start of World War II. As a learned politician and statesman who played a major role in the events of the time he clearly and critically examines the events of that era and in the light of those events, studies the hypocrisy and the double standard of today's attack on Eastern Europeans in the guise of a Nazi war criminal hunt.

### DOUBLE STANDARD

To consider events of half a century ago by today's propaganda criteria from a historical viewpoint, whilst looking at the tendentious political need of an enemy - is nothing more than a guarantee of falsification of historical facts and their continuity with historical processes.

Some justify Chamberlain's and Daladier's Munich as appeasement of a dictator by a militarily weak Britain as well as the righting of a wrong from the Versailles Agreement as to the Sudeten Germans.

Some regard the Anschluss of Austria as a re-unification of German lands, "Heim ins Reich" or Home in the Whole State, and thus true to Wilson's principles of self-determination. By analogy the same applies to the inclusion of the Saar territory. Chamberlain himself justified the Saar and Austrian issues,

if nothing else, as a recognition of their German ethnicity.

Aside from Britain's military unpreparedness, which was the justification for appeasing a dictator, there was also Chamberlain's innate honesty as to the issue of self-determination - an issue given credence by the spokesman of the Catholic Church, Cardinal Innizer of Austria, who greeted Hitler as the unifier of all German lands when personally welcoming him in "German fashion" at an audience.

Carl Renner, the Austrian socialist leader, and much later President of Austria, also greeted Hitler's Anschluss as a joining of the one people - the Germans. Socialists in Austria joined others in accepting the idea of a unified Germany and considered Austrians as Germans. The Austrian people as a whole welcomed this turn of events and evidenced support. They did not regard themselves as being under occupation. Pope Pius XII concluded a Concordat with Nationalist Socialist Germany, citing the legality of the elections that brought them into power. Great Britain concluded a military tonnages treaty, and all Polish leaders, Pilsudski, Moscicki and Beck, signed cooperation agreements - all this in 1934.

The world knew of Hitler's dictatorial bent, the racism of the Nazi Party and its extreme anti-semitism and juden-phobia. It's as well to remember that apart from concentration camps then functioning in Soviet Russia they also came into being in Germany and even Poland - where in Bereza Katuska Poland interned Ukrainian patriots, students, nationalists, priests and even dissident Poles.

The western powers knew full well what Nazism and Hitlerism was, yet this had not prevented the signing of a series of Friendship Agreements with Germany.

Could they not have been aware of the Kazetten and anti-semitism; or the reason for Einstein's exile; the wholesale flight of intellectuals; and then of course Krystal Nacht?

Not until Hitler discarded his self-determination camouflage and invaded Czechoslovakia did the West perceive the danger to itself.

Is it not possible, using today's terminology, to view the West as collaborators of Hitler's Germany?

Was it not a form of collaboration, in today's terminology, for Moscicki's Poland to attack Czechoslovakia from behind and occupy its Zaolzia Province? Is it so easy for the Polish Congress Committee to throw about accusations of collaboration at the Ukrainian Galizien Division? What about Pilsudski's pact with Hitler, or even more to the point, weren't Stalin's Commissars war criminals as a consequence of the Molotov/Ribbentrop Pact, and the subsequent two year supply of war material such as petroleum products, wheat, etc. Did not Moscow and Hitler divide the spoils, and Moscow manoeuvre Germany into a war?

Stalin & Co. weren't tried at Nurnberg, yet as a wolf shares with a hyena, so did bolshevism and nazism share the booty. Was it not collaboration for Moscow to provide Germany with fuel during the Battle of Britain? What about the occupation of France, Belgium, Denmark and

Holland, while Stalin swallowed Finland and the Baltic states? Was Moscow not aware of what was occurring in Auschwitz and Treblinka, as they helped Hitler with the attack on Britain?

But this is not all. Wasn't President Karstens of West Germany a member of the NSDAP? Did not ex-President Lubke also of West Germany, as a young architect, draw up plans for large buildings which were later used as the main concentration camp structures? He surely did not know what then occurred? Many ex-Abwehr generals later rebuilt the German Army as the Bundeswehr, and wasn't more than one of them NATO commander in chief? How many Nazi generals from the Western Front later served for years in East German armed forces, whilst concentration camp guards trained and acted as Honecker's camp guards?

Hitler came to power democratically, but by Can we blame all Germans for Hitlerism's crimes, or all Wehrmacht Generals, or even all Nazi Party members? Even President Karstens? On another tack, how many Jews were saved by Roosevelt by personal intervention? Chances had existed. Didn't Churchill know about the Pogroms, even in Poland? Eden did not know? Did General Franco receive the Accolade of the Righteous for saving 100,000 Jews during the 2nd World War? Is Israel just in this area? What do the defamers and Wiesenthals say about Belgium's Leopold III who surrendered Belgium without a shot being fired? Eden hushed up the Katyn "matter" in order not to anger the Russians. The anti-Jewish excesses of the -Black Hundreds in Czarist times and early bolshevik butchers is hardly mentioned. All this is taboo?

Now let us turn to the sacrificial lambs of the Wiesenthals and other anti-Ukrainian Jewish and non- Lewish defamers. Let us lay to rest the canard, that the Hebrew people are being blamed by us for anything, or are collectively guilty, having suffered so much from Nazi and Bolshevik holocausts. Just visualise the Danteesque scenes in Ukraine, Lithuania or Byelorussia. The year 1941. The advance of German Armies of the Wehrmacht - not Nazi gauleiters - in the first wave. On their approach Bolshevik guards flee. Prisons in Lviv, Lutsk, Rivne, Vinnytsia and many others are revealed to have hundreds of corpses of Ukrainian men and women - corpses upon corpses with eyes gouged out, women with mutilated breasts, disembowelled heaps of humanity, crucified priests in cellars - all in all thousands upon thousands of victims: the handiwork of the NKVD or pre-cursor of the KGB.

People's memories however are recalling the 7,000,000 famine dead in Ukraine in 1932-33, the communist deportations, dekulakisation, the times of Dzerzhynsky, Yagoda, Beria, Stalin... Whilst here people see an Army of the Occident appear - not necessarily Nazi, or German, but a civilised European force bringing freedom and human and national rights. To the intelligent people come to mind not Asian or Ukrainian African hordes but Goethe, Schiller, Beethoven, Bach, Kant... Can a people who produced such giants carry unmitigated evil? Chamberlain and the heir to the British throne had met Hitler; the Pope concluded a Concordat; and Hitler had always spoken of self-determination... And here are mountainous piles of bodies in prisons the work of the occupier from the Orient, the bolshevik horde.



Stepan Bandera - leader of the mass patriotic movement Organisation of Ukrainian Nationalists (OUN) which fought on two fronts, against Russia and Germany, in World War II. He was imprisoned by the Germans in a concentration camp. He was assassinated in October 1959 on orders from the Politburo by a Russian agent using a specially made gas-releasing pistol. He has become a national hero and a legend, and his name is synonymous with Ukrainian nationalism.

Churchill had stated that he would have the devil as an ally against the Hitlerite enemy. To Ukrainians, particularly in the western half, Moscow was an enemy and maybe even a German Lucifer could rid them of the bolshevik devils. When Ukrainians greeted the German Army it was not because it was National Socialist, but rather that they had had enough of the taste of Russian communism and colonialism and because they had faith in a Christian Europe. Not their fault that such an Europe did not exist at the time, but a Satanic system which mirrored the Lucifer from the Orient.

Didn't Churchill, much later, own up to his mistake too, and say "We killed but one swine and not the other too". Ukrainians reacted faster than the prescient Churchill, soon realising there was no Christian Europe but a Satanic Europe mirroring the Hell of Russia. They opened a two-fronted struggle against both evil systems. Heads should bow in the face of this heroism of the Ukrainian nation. It should not be a spittoon for Western snobs, who continue to live in ignorance of what went before, or worse, have been conned by the Lucifer from the Orient and laud the "paradise" of the devil on earth on the other side of the Iron Curtain. Let them go there to live!

Ukrainians do not cringe from the fact that in the early days they generally welcomed an Occidental Army, supposedly humane, Christian and committed to freedom. But they are angered, that in the West, many of those that sought a "modus vivendi" with Nazism in London, or Paris or even the Vatican do not stir themselves to accord similar defensive rights on Ukrainians, who rather quickly did carry a two-front battle,

continuing to warn of the designs of bolshevism.

The decline of Christian and Humanist values in the West is not rooted in blame-worthy lapses of a few individuals in Ukraine, Lithuania or Byelorussia, but can be blamed on the decline in Western Churches, the post-Versailles system, that had been erected on premises of revenge and distrust of new nations, as well as general collapse of heroism, the rise of untrammelled egoism, materialism and hedonism, including above all relativism of national values suppressing values of emerging nations.

That giant of Christian thought and action, the Ukrainian Catholic Metropolitan Andrew Sheptytsky cared, and protested to the German occupying authorities that they instigated and tolerated an anti-Jewish holocaust in Ukraine. Yet the pseudo-just state of Israel in its search for accommodation with post-Stalinist Soviet Russia refused to recognise him as one of the Just at -Yad Vashem, though the Chief Rabbis spoke up for his inclusion. Ukrainians have no need to seek to threaten or cajole Israel in honouring that great man. What is of moment, is that Israel has acted unjustly and ungratefully, their gratitude being measured rather by the self-interest of the ruling circle. There are numerous Jewish friends of ours in Israel, who in like manner evaluate the lack of fairness and bias - thus securing esteem in the face of the utilitarianism of the Kremlin.

Where is Wiesenthal's chase for war criminals amongst ethnic Russians or the members of war time Judenrat? Is it because it is "unseemly" to use the Russian term for it, or because "there are none left". There are also "no more

in the German Democratic Republic", but he does see still more, exclusively it seems, amongst Ukrainians, Lithuanians or Byelorussians. Weren't there any sadists of Jewish background in the NKVD in Lviv or Rivne or elsewhere? And Katyn, or Vinnytsia or Dresden? It's of no interest. He sees Ukrainians everywhere, as does the KGB.

Is it not beneath contempt, that one German paper's reaction to the news that charges against Demjanuk have been undermined, refers to a "Ukrainian sub-human". Should everybody talk of German subhuman beasts, or Jewish subhumans in the mould of Kaganovich, Yagoda, Trotsky etc., and the other functionaries of the Cheka or NKVD of Jewish blood?

Ukraine and Ukrainians are fair game to defame, but to answer back with home truths is not allowed - Verboten... Hundreds of thousands met Chamberlain at the height of the Sudeten Crisis, even though he had met with the Hitler "creature", who was referred to then as Herr Hitler.

Stock should be taken of the stand of others, who in the end were perhaps wiser than Western statesmen and took up arms against both creatures - Hitler and Stalin and are not wailing that they opened up a two front war, where one of their opponents would emerge the victor and "repository of truth". Not might is right, but justice cries out to the new Western world, not to the Wiesenthals, to cease rationalising their tactical blunders in the face of the perspectives of history. Didn't the Roosevelt liberals deliver up half of the civilized world to bolshevism, at the same moment forcefully

repatriating hundreds of thousands of former prisoners and refugees into the hands of the devil, though Churchill claimed "We killed one but not the other swine". Was it not a war crime to drag screaming mothers with infants in arms, those who didn't leap into rivers, into the clutches of waiting representatives of the devil just in order to follow Eden's edicts as "honouring" the decisions of Yalta, Tehran or Casablanca. The Atlantic Charter suddenly vanished. Surely it was a crime not to regard Stalin as "sub-human", as he was the master of the German "sub-human". Churchill forgot at the critical moment that balance of power had been the mainstay of British power in Europe by delivering that power to Stalin at the urgings of Roosevelt.

Today power is exercised by the Muscovite The flaccid West acts "sub-human". no-one saw that the real "sub-human" is not the wrong Demjanuk, but the creatures that occupy the Kremlin. Why doesn't the world reflect, that the greatest of collaborationists and known war-criminal, Molotov, still breathes. What about the responsibility of the Communist Party of the Soviet Union? Doesn't it answer for the Hitler-Stalin Pact, that paved the way for World War II? Not the 92-year old Hess, whose file is not to be declassified until after the year 2000? When will the Kremlin "sub-humans" stand trial for Vinnytsia, Katyn or the Ukrainian Artificial Famine of 1932-33. Is Wiesenthal going to chase Kaganovich or Yagoda or the covert KGB assassins in the West? Strange! Is it "something else"? But maybe it is the same "Mafia", the same crew?

Why the genocide and holocaust inspired by Moscow in Afghanistan, where children are being

slaughtered in front of their barbed-wire tied mothers? Or the family groups on leaking boats from Vietnam being killed by "pirates" or are they really Pol Pot residue? Is that not a Holocaust?

Everywhere two standards! A bolshevik can initiate ten times worse holocausts as the now defunct nazism, and that in full view of the powers that be - but a reaction of deeds against that be none! Was Spengler wrong?!!!

#### APPENDIX A

### PETLURA'S ANTI-JEWISH POGROMS

(by Josef Lobodowski)

[An article by the well-known Polish poet and publicist about historical facts and untrue "accusations". It appeared in the Polish newspaper "Gwiazda Poliarna", 19th October, 1985.]

From the time of Symon Petlura's death on a Paris street in May 1926, sixty years have passed, but controversy rages even now - who was Petlura's killer, Schwartzbart?

Was he avenging the death of his family, which had perished during a pogrom of Jews in Ukraine, or was he an agent of the GPU (forerunner of the KGB), - i.e. a Bolshevik terrorist-provocateur.

A large propaganda machine accompanied the Schwartz-bart trial in Paris. It was conducted by Jews, supported energetically by the press, both Soviet and Western communist. The court brought down a "Not Guilty" verdict on Schwartzbart, who thus became a noble avenger and a hero.

In reaching the verdict, the court did not consider the criminal record nor communist activities of Schwartz-bart. Strange also, that the "avenger" waited all of eight years to take "revenge" - which he took soon after the May changes in Poland in 1926. Polish Eastern Affairs experts did not doubt then, nor do they now, what Schwartzbart's role was nor his motives in carrying out that crime. Schwartzbart himself, on being freed, toured Europe with a set talk "How I

killed Petlura" and only did not obtain a visa from the Polish government.

He soon vanished, and following him, a certain Volodin also vanished. Volodin had gained the trust of Ukrainian emigres and, it would seem, played an active part in preparations for the assassination. When he returned to the USSR he was arrested and died in a Bolshevik camp.

When some years ago, the Polish magazine "Kultura" laid a wreath on Petlura's grave, a storm of protest erupted, fuelled by my article in that periodical. Lately, this affair was recalled by the well known Simone Signoret. Abandoning a film career, she wanted to gain laurels by her debut-making novel "Adieu Volodia". (Signoret, real name Kaminker, was a relative of Schwartzbart's.) She caused a great scandal, resurrecting the Anti-Jewish pogroms of Petlura.

In May 1985, whilst in Paris, I visited Maison-Lafitte. The editor, Jerzy Gedrojc, complained in a private conversation about not being able to find a Jewish writer who would comment on the affair of the assassination by Schwartzbart, and his motives – so uncritically accepted by the 1926 tribunal in Paris. During a fragmented conversation I never found out whether Gedrojc was aware of the excellent article by Israel Kleiner in "Forum". This magazine, in Russian, edited by Malynkovich (a recent exiled Soviet dissident) at the Suchasnist publishers, has an editorial staff of 16, of whom the majority or at least half of the editorial membership, are composed of Jews who had recently emigrated from Russia and Ukraine.

Kleiner's article commented on the book by Professor Samuel Friedman, "Pogromshchik", some year earlier. In a persuasive way, Kleiner rebutted all of Friedman's argumentation point by point. He brought up Petlura's

journalistic activity, even before the October Revolution and pre World War I. Petlura came out against the anti-semitism of the Black Hundreds Russian reactionaries. His paper, "Ukrainian Life" in Russian, had many Jewish contributors, amongst them the well known leader of socialist Zionists, Vladimir Zhabotinsky.

Mass pogroms began in Ukraine in 1917, when the Russian Czarist Army was disintegrating. Initially they were carried out by men fleeing the front, or armed bands of deserters; also, after the collapse of German occupation, groups of anarchistic Otamans (war-lords), village partisans, Denikin's White Army and even the Red'Army. After the Paris trial, all these pogroms were attributed to Petlura.

Soon after Petlura's death in 1926, Zhabotinsky wrote in the Jewish paper in New York, "Der Morgen Journal" thus: "Neither Petlura nor Vynnychenko (another leading Ukrainian socialist power-broker), nor other leading members of that Ukrainian Government, Ukrainska Narodna Respublyka, were 'pogromshchiks'. I did not know either personally, but the type of Ukrainian member of the intelligentsia of socialist and nationalist views, was known to me. I grew up with such men, and we led a similar war with anti-semitism and pro-russifiers, Jewish and Ukrainian as well. Neither I, nor the other Zionists from the South of Russia, can be persuaded that these people can be regarded as 'anti-semitic'."

In the wake of Zhabotinsky's article, all hell broke loose from all quarters. As a result of different pressures, a year and a half later Zhabotinsky wrote a letter to a Paris Russian emigre paper, with the title "Petlura and Pogroms". In that letter, he did not accuse Petlura of organising pogroms, but only expressed the view, that as Petlura was the leader of the Ukrainian Government, he could not absolve himself

from political responsibility for the pogroms, and if he could not stop them, should have resigned as the head of Government and Armed Forces commander.

The newspaper "Tryzub" (by Ukrainian emigres in Paris) which had close relations with Zhabotinsky's group, wrote after the assassination:

"In Ukrainian democratic circles the killing of S. Petlura by Schwartzbart has been taken not as having been carried out by Hebrews, but as a Bolshevik act, directed against a leader of Ukrainian democracy, who had been elected to head an armed struggle for Ukrainian statehood. The fact that Schwartzbart is Jewish, we regard as a terrible provocation by the Soviet regime."

One should say that in that era Jewish socialists were against organising Jewish self-defence. When such a plan surfaced, they said it would "assume a bourgeois character". I. Kleiner wrote about this in "Forum". Jewish socialists regarded the plan for Jewish self defence as 'nationalist', meaning 'reactionary'. Probably the most critical factor had been that the plan had come from "Zionists", whom Jewish socialists regarded as "bourgeois reactionaries". The socialists always feared that armed forces might fall under the influence of non-socialists, and then they, the socialists, would have lost their influence in the Jewish communities. Thus socialist ideology and party platform (not for the last time) became a hindrance to saving Jews. It is interesting to note that Petlura's socialist views did not prevent his giving support to the above-mentioned plans - but ideology did not permit Jewish socialists to grasp where the interest of the Jews lay.

One Jewish publicist, strongly defending Schwartzbart, not without irony asked me in the wake of my article in "Kultura":- "How many verdicts were carried out?" - referring to Petlura's orders, said to have

been issued by him, to shoot those who participated in pogroms, - and added, that to issue orders was one thing, to execute them another. I now want to bring to his attention the book published by Margolin (a former Minister for Jewish Affairs in Petlura's cabinet, and himself a Jew), "Ukraine and the politics of Entente". In his book Margolin gave 92 instances of executions of perpetrators of pogroms in the units controlled by Petlura.

Kleiner called Professor Friedman's book, which caused his reply in "Forum", "the most characteristic example of Anti-Petlura, meaning Anti-Ukrainian, propaganda". The book could easily have been published in Moscow. No wonder it garnered a succession of laudatory reviews in the Soviet press. The book is full of fulminating anger against the Ukrainian nation and everything connected with "Ukrainism".

"Jew-phobic Nation" - would anyone dare call any other nation, even Germany, thus? This is rampant racism, the dissemination of negative name-calling of a whole people, solely due to their racial or national belonging. Professor Friedman is shocked at antisemitism, though he himself is exhibiting the category of anti-semitic type. Was Ukrainian Metropolitan Andrei Sheptytskyi a "Jew-phobe" - the only churchman of World War II who openly came out against hitlerite extermination of Jews, whilst at the same time saving the lives of very many in his residence or Ukrainian Catholic monasteries.

To my knowledge Kleiner's article, though written in a measured tone, and based on documented evidence, was never reviewed or commented on in the Jewish press – negatively or positively. It was simply ignored. It wasn't noticed by the broad Polish emigre press which is a shame, as in Polish emigre circles one does not want for people who had believed the Anti-Petlura

and thus Anti-Ukrainian myth about Petlura's pogroms and the "avenger Schwartzbart".

The abovementioned issue of "Forum" came out three years ago, but it is worth remembering now, when Simone Signoret-Kaminker again offers demagogic, old, untrue allegations. Does the Volodia of her novel have anything in common with the Soviet agent Volodin, or is the similarity of names a coincidence - difficult to say. Signoret could have explained, but will she? (Signoret died in late 1985 - ed.)

#### APPENDIX B

### THEY DARE TO SPEAK OUT

Orwell's book "1984" was about how the "thought police" led by Big Brother controlled the future by controlling the past. Big Brother's slogan was "who controls the past controls the future, who controls the present controls the past". The most obvious control of the past (that is control of "history") by modern day "thought police" is the control of the history of World War II by the victors, and in particular, control of the "history" of the holocaust of Jews in WWII.

The reason that there is so much control over the official version of the holocaust of Jews is because the holocaust, as Zionist Jews assert, is Israel's "number one propaganda weapon". The allegation that there was a plan to exterminate Jews especially by "gassing" in "gas chambers" and that about 6 million Jews died is repeated literally daily in the media to secure support for Israel and divert attention from the case of the Palestinians.

Anti-Zionist Jews such as Dr. Alfred Lilienthal in books such as the "Zionist Connection", "There Goes the Middle East", and "What Price Israel" claim that the holocaust allegation is given saturation media coverage so that people are emotionally blackmailed into supporting Israel. Lilienthal claims that public

opinion is manipulated to favour Israel by Zionist controlled media outlets in the USA such as the Wash-ington Post, New York Times, the major TV networks such as NBC, CBS and ABC and the major film studios.

Continued and largely uncritical support for the 3 million Jews of Israel has alienated 500 million Muslims who retaliated by quadrupling the price of oil after the 1973 Arab Israeli war. This led to widespread inflation and unemployment in the West and its effects are still felt. Conflict between Arabs and Jews over Palestine is still the most likely cause of another world war. As Dr. Lilienthal asked – "What Price Israel?".

Holocaust propaganda is so effective in brainwashing people in the USA that more than  $\frac{1}{3}$  of foreign USA aid goes to Israel although only one person in 2000 in the world is an Israeli Jew. It is also so effective that any USA politician who calls for a reduction in aid to Israel or who calls for negotiations with the PLO is hit by a barrage of criticism from the Zionist controlled media, is faced by a well financed opponent in elections and is driven from office and from public life. This happened to Paul Findlay, who wrote a book "They Dare to Speak Out" recalling his experience.

The holocaust is so important as a daily propaganda weapon for Israel that revisionist historians who claim there was no plan to exterminate Jews, there were no mass gassings and that fewer than 1 million Jews died of all causes during WWII are persecuted, and their books banned by trade boycott. They have been persecuted in the courts for their views in the USA, West Germany and Canada, they are subject to character assassination in the media and given no right of reply, and a warehouse containing their books was burnt to the ground in the USA. Many civil libertarians such as Noam Chomsky and Alfred Lilienthal, both distin-

guished Jewish intellectuals (as distinct from academics) have protested against the attempts to silence revisionist historians, while other "civil libertarians" have been strangely silent, preferring to defend only the civil liberties of those with whom they agree.

Australia's first Jewish Governor General, Sir Isaac Isaacs, a great Australian jurist, who believed the Jews should assimilate into the countries in which they lived, warned of the dangers of Zionism and the dangers of displacing Arabs (whose fellow Arabs control so much oil) from their homeland. Sir Isaacs, Dr. A. Lilienthal and many other anti Zionist Jews are right. But many Jews and Goys are intimidated by the Holocaustmania of the USA media.

The failure of academics and "fearless" investigative journalists to challenge the exaggerations of the Holocaust is the greatest intellectual scandal since the end of WWII. This failure and the failure to place the Jewish Holocaust in proper perspective among many other and often worse holocausts, is one reason that President Reagan can talk of the likely fulfilment of the biblical prophecy about Armageddon arising from the Middle East.

Control of the past as far as it affects Israel is not confined to the Holocaust. The terrorist origins of the State of Israel including the massacres of British soldiers and administrators at the King David Hotel and of Palestinian villagers at Deir Yasin are not generally known. The part played by Nazi Zionist collaboration in promoting Jewish immigration to Palestine has been demonstrated by L. Brenner, an anti Zionist Jew, in "Zionism in the Age of the Dictators", but again this information has gone down the Orwellian memory hole. The claim that Jews are entitled to Israel because it was the home of their forefathers

has been refuted by the Jewish writer A. Koestler ("The Thirteenth Tribe) who demonstrates that most Jews are of Khazar, not semitic stock, but this refutation is generally ignored by the media. Incidents such as the attack on the USA warship the Liberty by Israeli planes leading to the deaths of 37 US seamen are censored out of the mainstream media.

#### APPENDIX C

# ZIONISTS "MISSED" COMMUNIST POLITICAL AND WAR CRIMINAL LISTS!

Actually war crimes and war criminals are only a small part of political crimes. What are political crimes and political criminals? The short answer may be as follows: when regimes of a country, or their organisations suppress, persecute, arrest, imprison, torture or kill people on political, national, religious or racial grounds, this is a political crime. The people who plan this and give the orders to execute those acts are political criminals.

As we can see war crimes and war criminals are only a part of the political crimes which take place during war time between opposing nations, but principally on the same grounds as mentioned above. Periods of war may last a number of years, for example World War I and World War II lasted 4-6 years; whereas political periods of despotic regimes may last for decades. The USSR, Red China, Vietnam, Cambodia, Cuba etc. have existed for decades, therefore their political crimes exact many more victims than their war crimes. As an illustration it could be mentioned that World War II demanded from both sides about 30 million victims, while the Soviet Union's "People's Democracy" during the last 69 years caused the deaths of about sixty five million innocent victims!

### ZIONISTS CAMPAIGN TO HUNT ONLY NAZI WAR CRIMINALS

As already mentioned there are, besides Nazi war criminals, also communist political criminals and communist war criminals. But the Zionists have selected only one small section of Nazi war criminals and for certain reasons have "forgotten" the great part of communist political and war criminals, disregarding all international conventions, human rights and even the ten commandments because the killing of innocent people either by Nazis or by the communist NKVD or KGB is just the same crime! Therefore the Zionist "Nazi hunt" campaign is one-sided and selfish, serves only Zionist interests and as such it should not be financed by taxpayers' money but by normal legals procedures through the police and courts; the legal costs should be the responsibility of the Zionist organisations.

### ZIONISTS' SOURCE OF EVIDENCE - THE KGB

In all cases of the "Nazi hunt" campaign the main evidence against the accused consists of a) documents, b) statements of witnesses and c) various extracts from publications. The majority of Nazi concentration camps were in the Polish territory of 1939. The collapse of the Eastern Front of Nazi Germany in 1944-45 forced the German Wehrmacht to suddenly retreat from Polish territory leaving in the concentration camps not only the inmates but even documentation of the camps and some of the administration. The KGB now, using modern scientific techniques, can reshape the documents to their own advantage. Despite the fact that between Israel and the USSR there have been no diplomatic relations since 1967 the Israel Mossad and the USSR's KGB have established "fraternal" co-operation to hunt the "Nazis".

what small extent the KGB-supplied documentation can be trusted is amply illustrated by the fact that the Soviet secret police chiefs Jagoda, Yazhev and Beria "made confessions" that they were foreign spies and were executed!

The KGB supplies the incriminating "evidence" not only to Israel but also to the US courts! And here is the irony of US justice: the US sends representatives to the Soviet Union to get evidence from "witnesses" whose translators are KGB-presented local people. To go even further, the US Justice Department makes a farce of US justice because while the State Department regularly repeats its non-recognition of the forceful incorporation of the Baltic states into the USSR, the Justice Department recognises as completely bona fide the KGB-produced evidence accusing Baltic migrants. This evidence comes from the Zionist-organised OSI (Office of Special Investigations).

# ZIONISTS DOMINATE THE US SENATE, HOUSE OF REPRESENTATIVES AND PARTLY THE WHITE HOUSE AND ITS ADVISERS

This is most visible when the US administration tries to sell some armaments to the friendly Arab states like Saudi Arabia, Jordan or Egypt. There are generally about two thirds of the Senate and a similar proportion of Representatives who object to the sales. This simple fact explains the rest of the US administration's subservience to Zionist pressure.

Israeli member of parliament (Knesset) Uri Avenim wrote in the Israel daily Haaretz on this subject as follows: "The New York Times has published a detailed press investigation on the methods used by pro-Israeli lobbies to influence presidential elections in the US. The study revealed that pro-Israeli institutions have

allocated \$4.25 million to be spent buying the minds and votes of Senate and Congress members. (Author's emphasis.)

Also it should be added that the \$4.25 million is not Israel's own money but only a small fraction of about \$3 billion of the US financial aid given to Israel. In other words Zionists buy US minds and votes and exercise political power in the US with a small fraction of the US aid to Israel. Now it becomes more than clear why the KGB documentation is acceptable in US courts. But here again, in the case of Shcharansky, the KGB documentation and accusations against Shcharansky for spying were "fabricated" by the KGB according to the Zionists and their media.

The conclusion is the KGB evidence relating to the Balts, Ukrainians, Byelorussians etc. is "clean" and should be trusted in the courts, but when the evidence of the KGB applies to a Zionist it is "fabricated". This is how the Zionists, the majority of the US media and the US Justice Department operate.

# WHY DID THE ZIONISTS WAIT 40 YEARS TO "HUNT THE NAZIS"?

Here, perhaps, are a few reasons. First of all the Zionists for a couple of decades were not firmly established in Israel because of dangers mainly from Egypt and other Arab states. Their main attention was to concentrate diplomatically and propagandistically to secure the future of Israel. Now this aim is completely achieved, the Zionists may use their energies in other sectors of their political field.

Another motive for starting this campaign so late is that some years ago they were not one hundred per cent sure of so easily dominating the political life of the US, especially the Department of Justice. But now, as the quotation from the member of the Israel Parliament, Uri Avenim, shows, the Zionists have bought political power with US dollars in all fields of US politics and this encouraged them to organise the OSI.

The final and most genuine motive for such late action against the "Nazi war criminals" is the Zionists' old dream of restoring diplomatic relations between Israel and the USSR. They have been trying to please the bolsheviks as much as they can with their "Nazi hunt" and to quieten the strongest anti-communist element in the Western World - the Baltic and Ukrainian political refugees.

WHY ARE ZIONISTS FRIGHTENED TO INVESTIGATE AND PUNISH COMMUNIST POLITICAL AND WAR CRIMINALS?

Since the Zionists started the campaign to "hunt Nazi war criminals" they were reminded constantly by East European migrants and by prominent US lawyers that Nazi crimes are only a small portion of the crimes committed by the communists. But the Zionists have refused to give serious explanations for this and refuse to talk about communist crimes.

Communist crimes committed since 1917 in the USSR including the war-time crimes are the most fearful historical sin facing the Zionist movement which they will never succeed in escaping from, despite their political power machine in the US and to a lesser degree in other Western nations. There are established historical facts proving that the Zionists were the most decisive element in the creation of the first communist state in the world - the USSR. The author of the hook "The Rulers of Russia", the Irish priest Rev. Denis Fahey, CSSp., D.D., D.Ph., B.A., writes in

his book: "According to data furnished by the Soviet press, out of the important functionaries of the Bolshevik state ... there were in 1918-1919, 17 Russians, 2 Ukrainians, 11 Armenians, 35 Letts, 15 Germans, 1 Hungarian, 10 Georgians, 3 Poles, 3 Finns, 1 Czech, 1 Karaim, and 457 Jews". Similar quotations could be presented here but the simple historical fact remains that the most vital element in the creation of the Soviet Union were Zionists. Lenin alone, without their finance and brains, would have failed to achieve his aim.

## COMMUNIST CRIMES IN THE USSR DURING "PEACE" AND WAR-TIME

To mention all Soviet communist crimes it is necessary to refer to many volumes of books; however let me restrict myself to mentioning only the more important ones. Trotsky as the War Commissar was the actual ruler of Russia during the revolution 1917-1922, his victims being prisoners from the White Russian armies, the bigger landlords, and all those who supported the Tsar - monarchists, religious leaders, businessmen etc. Millions of people perished during 1917-1922 as the result of cruel Trotsky's Red Army activity.

Concentration camps were an invention not of Himmler, as falsely propagated by the Zionists, but of their own Soviet chiefs of the secret police: Jagoda, Yazhev, Beria, Andropov etc. The horrors of psychiatric hospitals for political prisoners even surpassed the cruelty of the concentration camps. These Soviet "institutions" have accounted for the deaths of untold millions of innocent victims for the sake of the proletariat dictatorship. The biggest single crime in history was Katyn, where about 14,000 Polish officers and men were killed by the NKVD.

But the major crime of history was the conspiracy to start World War II. Zionist propaganda blames only the Nazis for this conspiracy. Yet a Nazi document which surfaced after World War II expounded the following Nazi-Soviet relations:

In January 1939 the Soviet ambassador in Berlin, A. Merekalov, visited the foreign office of Nazi Germany to explain briefly that the USSR was interested in beginning a new period of co-operative economic relations with Germany. This was the main preliminary move which led later to the conspiracy of the so-called Ribbentrop-Molotov Pact: subdivision of Eastern Europe between the Nazis and the Soviets, beginning with the joint attack on Poland - the commencement of World War II which killed some 30 million people on both sides.

I think the last two sections of this article sufficiently explain why the Zionists avoid touching on the crimes and the criminals of the communists in the USSR.

## THE MOST PRIVILEGED AND "PERSECUTED" NATION OF THE USSR!

We have a paradoxical picture of the Jews in the USSR. On the one hand the Zionists and their media in the Western World depict the Jews in the USSR as exceptionally economically, culturally and religiously suppressed and persecuted, while on the other hand there are reliable statistical data and historical facts to prove that the Jews there, in comparison with other nationalities, are in a privileged position. Where is the real truth?

First of all the book "Jews in Russia and the USSR" by Andrey Diky (New York, 1967) quotes the USSR 1959 census figures stating that at that time there were in the Soviet Union 208,828,000 people of whom 2,268,000 were Jews, or 1.1% of the country's population. But the same statistics show that Jews account for 11% of the scientists, 10.4% jurists, 14.7% doctors, 8.5% writers and journalists, and 7% actors, artists and musicians. These USSR population figures may be different today but the percentages will be similar to those quoted for 1959. Those statistics show that the Jews in the USSR are not economically deprived and are in a much better position that the other nationalities in the USSR.

The power of the Zionists in Soviet Russia is illustrated by the historical fact that the Peace Treaty of Brest-Litovsk between Soviet Russia and the Kaiser's Germany was negotiated and signed by four Jews in 1918: Trotsky, Joffe, Karakhan and Komanev. The same book names 12 prominent persons in the culture and education field in 1936-39 all of whom were Jews. Also there is a list of members of The Atheist Union all 20 of whom were Jews.

Gustav A. Wetter, one of the authors of the book "Dialectical Materialism" on page 493 quotes a message of congratulation to Stalin by Chief Rabbi of Moscow, Chorbutskyj, in November 1942: "On behalf of the practising Jews we send our heartfelt prayers to the Almighty so that He will bestow upon You, our beloved Leader, chosen by God (my emphasis) unlimited wisdom and strength for the speedy and complete destruction of the hannibal Hitler. We, the practising Jews, are deeply convinced that God will bestow victory upon our heroic Red Army, now marching from one victory to another, under the immediate leadership of the honourable banner of the Great Stalin."

It is necessary to recognise that a victory by Hitler in 1942 would have been a death threat to many Jews but the above message of the Moscow Rabbi on behalf of Soviet Jewry also shows an historical glorification of another hannibal even worse than Hitler because according to the Zionists' statements Hitler killed six million Jews but Stalin, supported by his Jewish state apparatus, was able to kill ten times more Christians of many denominations plus Moslems. This Moscow Rabbi's congratulation to Stalin is a typical symbol of the Soviet Jewry's support and co-operation with Stalin's regime instead of hoped-for opposition to it, or at least neutrality to it.

#### THERE IS NO CONDEMNATION OF NOR RESISTANCE TO COMMUNISM FROM ZIONISTS

It has been observed over centuries by many nations that if a ruling regime begins to suppress and persecute a specific nationality or a section of the community on political, religious, national or racial grounds then, as a rule, that regime experiences condemnation and strong resistance from the rest of the population. Now, if we take the case of the Jews in the USSR, the Zionists present in the Western media (which is dominated by them) daily reports about Jews being persecuted in the Soviet Union. But surprisingly the Zionists do not take any serious punitive measures against the Soviets to support their brethren behind the Iron Curtain. The Zionists' political power in the US could easily enable them to "convince" US Senators and Representatives to take sanctions against the Soviets instead of against South Africa where Jews are lords of goldmining, the diamond industry and other businesses. But the Zionists for "some reason" are not interested in punishing the Soviets for the persecution of their brethren. Now, as well, take the Zionists' most powerful organisation, World Jewish Congress, which has never ever passed a resolution condemning the Soviet-Marxist system and communism as a political philosophy. Actually all the Zionists demand from the Soviet Union is to "Let our people

go". In other words the argument between the Soviet Union and the Zionists lies only in the freedom for Jews to emigrate from the USSR. The communist system, after that, can stay for ever!

That the conclusion above is not my personal opinion is proved by quoting some extracts from Israel President Chaim Herzog's speech when he was guest speaker at the Israel Communist Party Convention in Haifa on 5-7 December, 1985.

"We hope that the way will be found soon to remove obstacles and build anew friendly relations between the State of Israel and the Communist World in general, and in particular with the Soviet Union. have said on many occasions that despite profound differences of opinion regarding the conflict in the Middle East and in the matter of Soviet Jews, the state of Israel is not hostile to the Soviet Union. the contrary, the halutzim and the pioneers of the Zionist movement drew cultural and ideological inspiration from the Soviet Union...We remember with respect the enormous support of the Soviet Union in the fateful hour of the establishment of the State of Israel and the magnificent address of Andrei Gromyko - today the President of the Soviet Union - on November 27, 1947 (at the United Nations). I will add and recall that in the desperate Independence War of the State of Israel when our fate hung by a hair as a result of the almost complete embargo by the West, it was the aid which we received from the East that enabled us to endure. This we will never forget! "

"We seek to improve relations with all the Communist nations."

"It is in this spirit that I have the honour to greet your convention and wish it success and fruitful efforts."

It is necessary to add that to this Israel Communist Party Convention was invited and participated a strong delegation of the Soviet Union's Communist Party which certainly reported this speech of the Israel President to Gorbachev. The above speech was originally published by the Israeli newspaper "Jewish Post" on January 15, 1986 and was reproduced by "The Thunderbolt", Marietta, Georgia, USA.

Those extracts from the speech of the highest official of the State of Israel, also the highest official of the Zionist movement, announces clearly where the Zionists stand in regard to the Soviet Union and World Communism. Further comments are unnecessary.

Finally it is necessary to make a short analysis of the nearly three million Jewish population in the USSR. If these Soviet Union Jews are exceptionally deprived of cultural or religious activities and persecuted politically they should demonstrate some serious counteraction or resistance. As an illustration I will compare the Soviet Jews with another similar nationality also of about three million – Lithuanians – who also complain of political, national and religious persecution by the Soviets.

As the result of their persecution by the communist regime the Lithuanians organised a massive eight years (1944-1952) armed partisan resistance, but lost to the superiority of armaments and numbers of the KGB divisions. The population for twenty years now has been sending signed petitions in hundreds of thousands to Brezhnev, Andropov and now to Gorbachev and to the United Nations complaining about Soviet suppression of religious and national freedoms. Lithuanians developed a strong underground movement which since 1972 has regularly published Chronicle of the Catholic Church in Lithuania which, reaching the West, is translated into five languages and is well known by the

media. Besides this, the underground also publishes about a dozen other journals. This is only a very short list of Lithuanian resistance activity.

Now if we compare the Lithuanians with nearly the same number of Jews living in the USSR we find a few individuals from time to time appearing in Red Square as demonstrators, mainly in connection with emigration. There are lots of complaints from the Jews that they lose their jobs as soon as they apply for emigration. There are some leaflets produced by individuals and distributed among the local people and foreigners. Sometimes Jews in higher positions organise press conferences in private flats for foreign correspondents. That is the sum total of their activity as far as known in the West as published by the Zionists. But the Zionists in the USSR have no real underground activity, not even their own Zionist underground publication, no mass petitions complaining to the highest officials of the Party or Government. In short, Zionist activity against the Soviet communist apparatus is very limited, mainly casual and of an individual nature and has no wide support of the Jewish masses. reason for this is that the leaders of the Zionists on both sides of the Iron Curtain are pursuing a soft and sometimes very friendly policy towards communism as we can judge from the excerpts of the Israel President's speech.

#### CONCLUSIONS

1. Zionists refuse to mention communist political and war criminals because the list of communist criminals would probably be ten times longer than the list of Nazi criminals. But the real motive for the refusal is that some of the Zionists involved in communist crimes are living today in Israel, the US, Canada, Australia or Europe.

- 2. The migrants of nationalities accused by the Zionists should a) form joint international committees in the US, Canada, Australia etc., b) prepare a list of communist political and war criminals in co-operation between the committees of the above-mentioned countries, c) open bank accounts on behalf of the committees concerned in each country and raise the finance to defend the people who are involved in court proceedings.
- 3. Zionists delayed for 40 years the "Nazi hunt" action because they were not sure of support from the US administrations. But the human rights champion, Jimmy Carter, gave them the green light; the hard right-winger, Ronald Reagan, was afraid to change the law because he wanted to serve a second term in the White House...
- 4. The "Nazi hunt" campaign is the brainchild of the Zionists who are only a small part of the Jewish population but supported by a majority of bankers, millionaires and businessmen. Therefore the majority of Jewish people have nothing to do with this campaign.
- 5. The Zionists may succeed in finishing this campaign by delivering say a dozen East European migrants, accused on KGB-supplied evidence, to be executed by a KGB firing squad. But this "Nazi hunt" campaign by the Zionists has created an anti-Semitic wave for a generation in North America, Europe and Australia and its echoes will reach the people behind the Iron Curtain as well.
- 6. It would be wrong to say that because of Zionist influence in the USSR there was not Jewish persecution at all. It is not the aim of this article to prove such a nonsense. There were Jews in the USSR jails and concentration camps and they were punished in other ways for blackmarketeering, embezzlement deals with

foreign currency etc. In addition some individuals suffered for political activity. On a percentage basis, taking into account the proportion of various USSR nationalities like Balts, Ukrainians and Caucasians, the Jewish anti-Soviet activity was in the past and is at present almost negligible. Also it should be recognised that their influence in the Politburo has gradually diminished in the last decade or so, but economically Jews are still in a prominent position in comparison with other nationalities.

7. I would never have taken a pen to write this article if the Zionists had not begun in Australia such a campaign full of hatred – and in the Year of Peace.

#### APPENDIX D

### ERICH KOCH

The French press of November 1986 informs of the death of Hitler's henchman, Erich Koch. Koch, Hitler's right hand man, was the governor of occupied Ukraine during the war. In similar fashion to the previous Russian occupiers, Kahanovych and Khrushchev, he ordered mass liquidation of Ukrainians. In this way he was preparing the rich Ukrainian land for the 1000 years German Reich.

Recently the Australian press, in a reasonably small article, announced the death of Koch. The article included the information that Koch was responsible for the deaths of 70,000 Poles and 4,000,000 Ukrainians!

How does this fit with the claims, made persistently over many years, that Ukrainians were Nazi collaborators?

How, also, does this sit with the conscience of the media which almost daily refers to the horrors of 6,000,000 dead in the Jewish Holocaust, yet only once in forty years even admits to a death toll of 4,000,000 Ukrainians - a death toll which is by far understated. Add to this civilian figure a large number of those who fell in battle with the German Army and Gestapo. Add also millions of Ukrainians who, as prisoners-of-war, were starved to death in the German camps.


